TO THE HONORABLE JUDGE OF SAID COURT:

Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complains of Respondent, Bryan L. Walter, (hereinafter called "Respondent"), showing the Court:

I.

Discovery Control Plan

Pursuant to Rules 190.1 and 190.3, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level III Discovery Control Plan. Rule 3.07 of the Texas Rules of Disciplinary Procedure requires the court set a trial date for this matter to commence no later than 180 days after the date this Disciplinary Petition is filed with the District Clerk.

H.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition

was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Collin County, Texas. Respondent can be served at 1009 Henderson Street, Fort Worth, Texas 76102. Multi-Service Process will serve citation.

IV.

Respondent's ex-wife, Nytonya Spayde ("Spayde"), hired attorney Janice Schattman ("Schattman") to represent her in an ongoing custody dispute with Respondent in Cause No. 322-214249-94 styled "In the Interest of Danielle Bryana Walter, A Child" filed in the 322nd District Court of Tarrant County, Texas.

V.

On or about March 8, 2000, Respondent caused his current wife, Barbie Walter, to contact the office of Schattman and impersonate Spayde in an attempt to obtain privileged information from Schattman's staff about the custody matter.

VI.

On Friday, March 10, 2000, a temporary hearing began before Judge Frank Sullivan. The temporary hearing concluded on March 20, 2000 with the Judge taking the matter under advisement. Respondent engaged in *ex parte* communication with Judge Sullivan by submitting a proposed order directly to the court by fax on March 30, 2000, and later by submitting an original of the order to the court without providing opposing counsel a copy of either order as required by the local rules and rules of procedures.

VII.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs V and VI, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 3.05(b)(2) and 8.04(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VIII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Janice A. Schattman filing a complaint on or about May 18, 2001.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
