#### TO THE HONORABLE JUDGE OF SAID COURT:

Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complains of Respondent, Rowena Jenkins Daniels, (hereinafter called "Respondent"), showing the Court:

#### I.

#### **Discovery Control Plan**

Pursuant to Rules 190.1 and 190.3, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

#### III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has her principal place of practice in Hopkins County,

Rowena Jenkins Daniels - Disciplinary Petition Page 1 Texas. Respondent can be served through her attorney, John Gladney, at Arena Tower Two, 7324 Southwest Freeway, Suite 800, Houston, Texas 77074. Citation should be served via certified mail return receipt requested.

#### IV.

On March 2, 2001, a Judgment of Partially Probated Suspension was entered against Respondent. The 134th Judicial District Court of Dallas County assessed the discipline as suspension from the practice of law for a period of thirty-six months, with the first month being an active suspension and the remaining thirty-five months being fully probated pursuant to the terms and conditions of the Judgment. Respondent's active suspension from the practice of law began on March 5, 2001 and continued through April 4, 2001. The Judgment was served on both Respondent's attorney of record, Robert Wilson, and on Respondent.

#### V.

During the active time of suspension, Hollie Eisenhauer's ("Eisenhauer") firm was actively litigating a case involving Respondent as opposing counsel. Although actively suspended, Respondent filed pleadings with the Court on behalf of her client in violation of the March 2, 2001 judgment. During the course of representing this same client, Respondent additionally allowed her legal assistant to sign Respondent's name to pleadings that were subsequently filed with the Court.

#### IVI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs IV and V, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 5.03(a)(b)(1), 5.05, 8.04(a)(7) and 8.04(a)(11) of the Texas Disciplinary Rules of Professional Conduct.

V.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Hollie Eisenhauer filing a complaint on or about June 21, 2001.

#### PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
