This letter is to request a transfer of a companion case, 01-89-0660-CR, Tr. Ct. No. 493265), Alphonso Percival Darden v. The State of Texas to the Thirteenth Court of Appeals, Corpus Christi, Texas.

Your order of August 11, 1989 transferred 20 cases to the Thirteenth Court of Appeals, and the captioned case was transferred. The Thirteenth Court issued their opinion on December 7, 1989 (Case No. 13-89-00319-CR - Tr. Ct. No. 493264).

The State filed a motion on March 5, 1990, requesting a transfer of the companion case (Our No. 01-89-00660-CR, Tr. Ct. No. 493265) to the Thirteenth Court of Appeals. On March 15, 1990, we granted the transfer, pending approval of the Supreme Court. Our records do not indicate that we requested a transfer of this companion case from the Supreme Court, nor was the record forwarded to the Thirteenth Court.
