
Re: Transfer of Companion Cases

Dear Mr. Adams:

On August 5, 1993 we transferred Cause No. 05-93-01124-CR, *House v. State* to the Eleventh Court of Appeals at Eastland, Texas pursuant to the order of the Supreme Court issued on June 28, 1993. On August 11, 1993 we received two companion cases to that case, Cause Nos. 05-93-01289-CR and 05-93-01290-CR, *House v. State*.
