#### **DISCIPLINARY PETITION**

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, James J. Crook, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

# П.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in El Paso County, Texas. An officer may serve citation on Respondent at 109 North Oregon Street, Suite 602, El Paso, El Paso County, Texas 79901.

On or about December 3, 1991, Maria Mayela Holguin (hereinafter called "Holguin") hired Respondent to represent her in a divorce proceeding. At that time, she paid Respondent \$600.00 in attorney's fees. In addition, on or about December 17, 1991, she paid Respondent an additional \$326.00 for attorney's fees and court costs.

#### IV.

Respondent filed Holguin's divorce petition on or about April 14, 1992. Holguin's husband never appeared or filed an answer. A hearing was held on the matter on or about June 29, 1992, at which time the court granted the divorce by default and signed the final divorce decree. Respondent retained possession of the original signed decree and was to file it with the El Paso County District Clerk in order to finalize the divorce. Instead, Respondent gave the original decree to Holguin as proof that her divorce was final, and failed to file any documents with the district clerk.

#### v.

In and around August, 1992, Holguin's spouse entered an appearance in the divorce proceeding. His attorney contacted Respondent, who assisted in drafting a new decree which differed in several respects from the original decree signed by the court. At no time did Respondent inform Holguin that her divorce was not final because the original divorce decree was never filed with the district clerk, or advise Holguin that he was working with counsel for her spouse to draft a different divorce decree.

#### VI.

On or about February 18, 1993, the court where the divorce was pending issued a notice

of intent to dismiss for want of prosecution since there was no record of the prior judgment issued by the court in June, 1992. The parties set the matter for hearing on or about May 24, 1993, at which time a new divorce decree which differed from the original decree was signed and entered. At no time was Holguin informed of the May 24th hearing or advised regarding the contents of the new divorce decree. She learned of the new decree when Respondent sent her a copy on or about June 3, 1993.

#### VII.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV., V., and VI. hereinabove which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.01(b)(2), 1.03(a), and/or 1.03(b) of the Texas Disciplinary Rules of Professional Conduct.

#### VIII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Maria Mayela Holguin filing a complaint on or about August 20, 1993.

### <u>PRAYER</u>

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
