DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, L. Mickele Daniels, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent has his principal place of business in Harris County, Texas. An officer may serve citation on Respondent at his business address located at Arena Tower II., 7324 Southwest Freeway, Suite 1050, Houston, Harris County, Texas 77074.

POPINA NOTINA Ш.

On or about August 14, 1993, Antonia Cruz (hereinafter called "Cruz") was involved in an automobile accident which she suffered personal injuries. Four days later, Cruz was contacted by telephone by a women who identified herself as Vickie Valdez (hereinafter called "Valdez"), who identified herself as being a representative of the "Accident Victim's Hotline". Valdez informed Cruz that she received Cruz's name and telephone number from public police records. Valdez also mentioned that her company helped accident victims receive the help they needed, such as contacting doctors and lawyers.

IV.

On or about August 20, 1993, Cruz was picked up by a car sent by Valdez and was taken to Irving, Texas, to see a doctor and lawyer. The office Cruz was taken to was Respondent's Dallas office. At that time, Cruz was interviewed by Respondent's office administrator, Noli Casal (hereinafter called "Casal"). There was no attorney permanently stationed in Respondent's Dallas office, making Casal, a non-lawyer, essentially unsupervised in his administration of Respondent's Dallas office. Although Cruz did not see Respondent that day, she signed one of Respondent's form retainer contracts and power of attorney during that visit. She was also told by Casal that Respondent was "board certified".

V.

Thereafter, Cruz had difficulty obtaining information about her case from Respondent's office. Her telephone calls were not returned in a timely matter, if at all. Further, Cruz made several requests to see Respondent, but in fact never met Respondent until on or about September 2, 1993, when she terminated his services during a visit to his office.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV. and V. hereinabove which occurred on or after January 1, 1990, constitute conduct violative of Rules 5.03, and/or 8.04(a)(8) of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Cruz's filing of a complaint on or about November 18, 1993.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
