DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, William D. Perkins, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Angelina County, Texas. An officer may serve citation on Respondent by and through his attorney, Wayne H. Paris, 3100 South Gessner, Suite 600, Houston, Texas 77063.

Perkins - Disciplinary Petition Page 1 of 4 In or around April 1995, Cindy Williams Diggs (hereinafter referred to as "Diggs") engaged Respondent to represent her in probating her father's will and to collect the proceeds from her father's life insurance policies. At the time of his death, Diggs' father was in the process of divorcing his second wife, but the final divorce decree had not been entered. Respondent advised Diggs that she might be able to defeat certain of her father's estranged wife's claims upon the estate, and Diggs accepted Respondent's advice and relied upon him to pursue any interest she might have. Thereafter, Respondent collected the proceeds of the life insurance policy to which Diggs was entitled as the designated beneficiary and filed pleadings on behalf of Diggs in the probate court challenging the estranged wife's claims.

IV.

Upon learning the amount of attorney's fees Respondent had assessed against Diggs, Diggs consulted another attorney about Respondent's legal advice and the course of action taken in Diggs' case. After being advised that her case was weak and would not likely prevail, Diggs directed Respondent to contact the opposing party and attempt to settle the estate. Respondent, however, failed to abide by Diggs' decision and did not make a good faith effort to settle Diggs' case, as directed.

V.

From the time Diggs had hired Respondent until the time she dismissed him and sought other counsel, about six (6) months had passed. During this time, Respondent billed Diggs approximately \$45,910.50 in legal fees. Such fee was unconscionable considering the time and labor required, the skill requisite to perform the legal services, the novelty and difficulty of the

William D. Perkins - Disciplinary Petition Page 2 of 4 legal issues involved, the results obtained and the fee customarily charged in the locality for similar legal services. In addition, during this time, Respondent brought no settlement proposals to Diggs nor had he filed any pleadings in court whereby the matter might be brought to trial. By taking the position he did, Respondent unreasonably increased the costs or other burdens of the case, and he unreasonably delayed resolution of the matter.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III, IV and V, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.02(a)(1), 1.04(a), 1.04(b)(1), 1.04(b)(3), 1.04(b)(4) and/or 3.02 of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Cindy Williams Diggs filing a complaint on or about March 29, 1996.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.

Dear Judge Miller:
