#### **DISCIPLINARY PETITION**

#### TO THE HONORABLE JUDGE OF THE COURT:

The Commission for Lawyer Discipline ("Petitioner"), a permanent committee of the State Bar of Texas, files this Disciplinary Petition against Donna Henry-Rummel ("Respondent"), an attorney licensed to practice law in the State of Texas, showing the Court as follows:

#### NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the State Bar Act, the Texas Government Code Annotated §81.001, et seq. (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure. The complaints that form the basis of this disciplinary petition were filed on or after May 1, 1992.

#### 2. VENUE

Henry-Rummel is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Henry-Rummel is a resident of Galveston County, Texas. Henry-Rummel's principal place of practice is located in Galveston County, Texas. Therefore venue is appropriate in Galveston County, Texas, pursuant to Rule 3.03 of

the Texas Rules of Disciplinary Procedure.

#### 3. ISSUANCE OF CITATION AND SERVICE OF PROCESS REQUESTED

- Petitioner requests that citation be issued and process be served upon Henry-Rummel.
- 3.02 Henry-Rummel may be served at her business address located at 2538
  Wheelwright, Friendswood, TX 77546.
- 4. HENRY-RUMMEL COMMITTED PROFESSIONAL MISCONDUCT IN VIOLATION OF TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 8.04(a)(3)
  - 4.01 On or about December 1, 1992, Gaile Henry ("Henry") purchased a 1992 Toyota from Kinsel Ford Lincoln Mercury in Beaumont, Texas. Henry financed the purchase of this 1992 Toyota through Bank One. The terms of the financing required Henry to make 48 monthly payments.
  - 4.02 Sometime before, or after, purchasing the 1992 Toyota, Henry agreed to sell the 1992 Toyota to Sharon Kay Golightly ("Golightly"). Thereafter, Golightly paid Henry on a monthly basis for the car note and insurance premium.
  - Henry died during the latter part of 1994. Shortly thereafter, Golightly met with Respondent, the executrix and beneficiary of Henry's Estate. At that time Golightly told Respondent of her agreement with Henry regarding the 1992 Toyota.
  - 4.04 Sometime after their meeting, Respondent told Golightly that if Golightly paid

    Henry's Estate the balance of the note on the 1992 Toyota, which was approximately

    \$4,000.00, the title of the 1992 Toyota would be transferred to Golightly. On or about

    March 10, 1995, the balance of the note on the 1992 Toyota was paid in full. However,

the title of the 1992 Toyota was not transferred to Golightly as previously promised by Respondent. Respondent engaged in conduct involving dishonesty, deceit and misrepresentation in her dealings with Golightly.

#### 5. PRAYER

Petitioner requests this Court to discipline Henry-Rummel by disbarment, suspension or reprimand, as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled, including costs of court and attorney's fees.

Dear Judge Moody:
