TO THE HONORABLE JUDGE OF THE COURT:

The COMMISSION FOR LAWYER DISCIPLINE ("Petitioner") a permanent committee of the State Bar of Texas, pursuant to the authority of an investigatory panel for State Bar District Number 4D files this Disciplinary Petition complaining of W. WILBUR SUGGS ("Respondent"), an attorney licensed to practice law in the State of Texas, showing the Court as follows:

## 1. NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the State Bar Act, the Texas Government Code Annotated §81.001, *et seq.* (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure. The complaints that form the basis of this Disciplinary Petition were filed on or after May 1, 1992.

#### 2. VENUE

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of Harris County, Texas. Respondent's principal place of practice is Harris County, Texas. Therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of Disciplinary Procedure.

#### 3. ISSUANCE OF CITATION REQUESTED

3.01 Petitioner requests that citation be issued and forwarded to: Jeannette

individual processor.

South Loop West, Ste 500, Houston, Harris County, Texas, 77054.

# 4. PURSUANT TO PART III OF THE TEXAS RULES OF DISCIPLINARY PROCEDURE, PETITIONER REQUESTS THIS COURT TO DISCIPLINE SUGGS FOR ACTS OF PROFESSIONAL MISCONDUCT

# 4.01 SUGGS ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.01(b)(1).

(A) On or about May 22, 1995, Manuel Puentes ("Complainant")

retained the services of the Respondent on a contingency fee

basis to represent him in a personal injury case.

(B) Upon settlement of the case, which totaled \$21,000.00,

Respondent issued a check in the amount of \$5,100.00 to

Complainant.

(C) Respondent was then to pay necessary medical providers with the balance of the settlement.

(D) Complainant then began receiving notices for delinquent payments from 1) Harwin Medical Center, 2) Arrango Chiorpractic Clinic, and 3) South Post Oak Pharmacy for the next two years. Complainant continually contacted Respondent regarding those notices.
Respondent neglected to return Complainant's requests for information.

## 4.02 SUGGS ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.01(b)(2).

(A) Respondent neglected to promptly disburse funds in his account to

medical providers between the months of April 1993 to May 1995,

as had been instructed by Complainant.

# 4.03 SUGGS ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.14(b).

- (A) Complainant attempted to contact Respondent for three months to obtain copies of his records regarding payment of funds paid to medical providers.
- (B) Respondent never replied to Complaint's request for the

accounting of \$15,000.00 of Complainant's settlement.

### 4.04 SUGGS ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.14(c).

(A) Respondent did not keep the \$15,000.00 of Complainant's settlement separate from his own funds until there was an accounting and severance of interests.

# 4.05 SUGGS ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 5.03(a).

- (A) Respondent had direct supervisory authority over his non-lawyer employee, Mary Kent.
- (B) Respondent failed to supervise that employee whose responsibilities included writing checks concerning clients' settlements.

#### 5. PRAYER

Petitioner respectfully prays that this Court discipline Respondent by disbarment, suspension or reprimand, as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled, including costs of court and attorney's fees.
