DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF THE COURT:

The COMMISSION FOR LAWYER DISCIPLINE ("Petitioner") a permanent committee of the State Bar of Texas, pursuant to the authority of an investigatory panel for State Bar District Number 4E files this Disciplinary Petition complaining of **DIANTHA GARRETT BRENNAN** ("Respondent"), an attorney licensed to practice law in the State of Texas, showing the Court as follows:

1. NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the State Bar Act, the Texas Government Code Annotated §81.001, *et seq.* (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure. The complaints that form the basis of this Disciplinary Petition were filed on or after May 1, 1992.

2. VENUE

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of Harris County, Texas. Respondent's principal place of practice is Harris County, Texas.

Therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of Disciplinary Procedure.

3. ISSUANCE OF CITATION REQUESTED

- 3.01 Petitioner requests that citation be issued and forwarded to: Jeannette Duer, 1111 Fannin, Suite 1370, Houston, Texas 77002, for service by an individual processor.
- 3.02 Respondent may be served at her business address located at 210 Texas Banc Savings Building, Humble, Harris County, Texas, 77338.
- 4. PURSUANT TO PART III OF THE TEXAS RULES OF DISCIPLINARY PROCEDURE, PETITIONER REQUESTS THIS COURT TO DISCIPLINE BRENNAN FOR ACTS OF PROFESSIONAL MISCONDUCT.
 - 4.01 BRENNAN ENGAGED IN CONDUCT VIOLATING TEXAS
 DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.01(b)(1)
 - (A) On or about June 1993, **SHIRLEY A. LANGE** ("Complainant") retained the services of the Respondent to represent her in a divorce matter.
 - (B) Between June 1993 and March 1995, Complainant paid
 Respondent Three Thousand Six Hundred Thirty-Two Dollars
 (\$3,632.00) in legal fees.
 - (C) Between April 1995 and July 1995, there was no communication from Respondent to Complainant. Respondent led the Complainant to believe that the case was being pursued when, in

- fact, Respondent failed to take necessary action on behalf of Complainant.
- (D) On or about June 1, 1995, Complainant's case was set for trial and Respondent failed to notify Complainant of the June 14, 1995, trial setting.
- (E) Respondent then failed to appear at a June 14, 1995, trial setting on behalf of Complainant. A default judgment regarding Complainant's divorce action was entered against Complainant at that trial setting.
- (F) Complainant was forced to retain other counsel at a cost of Eight Hundred Forty-Two Dollars and Fifty Cents (\$842.50), to have the default judgment set aside that was rendered on June 14, 1995.
- 4.02 BRENNAN ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 1.03(a).
 - (A) On or about June 1995, Complainant's case was set for trial on June 14, 1995; and Respondent failed to notify Complainant or appear on behalf of Complainant at that trial setting.
- 4.04 BRENNAN ENGAGED IN CONDUCT VIOLATING TEXAS

 DISCIPLINARY RULE OF PROFESSIONAL CONDUCT 8.04(a)(11).

(A) When Complainant retained Respondent's legal services, Respondent had been administratively suspended since September 1, 1994, from the practice of law for failing to pay her bar dues.

(B) Respondent remained administratively suspended throughout the entire legal relationship, and until Complainant hired another counsel to set aside the default judgment rendered against Complainant.

5. PRAYER

Petitioner respectfully prays that this Court discipline Respondent by disbarment, suspension or reprimand, as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled, including costs of court and attorneys' fees.
