### **ORIGINAL DISCIPLINARY PETITION**

Comes now, Petitioner, the Commission for Lawyer Discipline, and would show unto the Court as follows:

### I. PARTIES

Petitioner is the Commission for Lawyer Discipline, a Committee of the State Bar of Texas.

Respondent is William David Bays, an attorney licensed to practice law in the State of Texas.

He may be served with process at his law offices, The Law Offices of David Bays, 707 Rio Grande,

Suite 200, Austin, Texas 78701.

### II. VENUE AND JURISDICTION

Venue is proper in Travis County in that:

- A. It is the county of Respondent's residence.
- B. It is the county of Respondent's principal place of practice.
- C. It is the county where the alleged Professional Misconduct occurred in whole or in part.

This Court has specific jurisdiction over this matter as provided by the State Bar Act, Tex. Gov't. Code. Ann. §81.001, et. seq. (Vernon 1988), the Texas Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure.

### III. FACTS

On or about July 24, 1996 and/or July 25, 1996, Elizabeth Tulliver was working at the Sun Harvest grocery store at 4006 South Lamar Blvd., in Austin. Respondent approached her, handed her his business card, and suggested that she could receive financial benefit by having an on-the-job injury. He told her that he could represent her in that claim.

## IV. VIOLATIONS OF THE TEXAS DISCIPLINARY RULES OF PROFESSIONAL CONDUCT

Respondent violated the following Texas Disciplinary Rules of Professional Conduct:

# Rule 7.03 (a) [Prohibited Solicitations and Payments]

Respondent contacted Ms. Tulliver in person. Through his actions and statements, he sought professional employment concerning a matter arising out of a particular event, from a prospective client who had not sought the lawyer's advice regarding employment. Respondent's primary motivation for these actions and statements was his own pecuniary gain.

# Rule 8.04 (a) (3) [Misconduct]

Respondent, by the actions and statements described above, engaged in conduct that involved dishonesty, fraud, deceit, or misrepresentation.

### V. PRAYER

### Petitioner prays as follows:

- 1. For recovery of reasonable attorneys' fees and court costs associated with the prosecution of this Disciplinary Action.
- 2. For the imposition against Respondent of appropriate Sanctions.
- 3. For such other and further relief as to which Petitioner might show itself justly entitled.
