DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas, complaining of Respondent, Gordon B. Morgan, showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex.Gov't Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed with the State Bar of Texas on or after October 30, 1995.

II.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas. An officer may serve citation on Respondent, by and through his attorney of record, Tina K. Salem, 4300 Scotland, Houston, Texas 77007.

III.

Kristin Way was the owner of Sloan Medical Clinic, which has gone out of

business. Sloan Medical Clinic provided medical services to a number of Respondent's clients under letters of protection which Respondent provided to Sloan Medical Clinic during a period from June 1994 through May 1995.

Following the periods of treatments, Respondent failed to either notify Kristin Way or Sloan Medical Clinic of the settlement of his client's personal injury cases and/or failed to issue full or timely payment to her clinic for medical services rendered to Respondent's clients.

Respondent failed to notify his clients and patients of Sloan Medical Clinic,

Anthony Blake, Rebecca Wallace, Felipe Rojas, and Jose Rosales of receipt of
settlement funds.

Respondent failed to maintain adequate attorney trust account records in his trust account number 35424 from June 1, 1994 through July 31, 1995, to show whether he had maintained the funds to pay the medical provider.

Respondent failed to promptly deliver funds to Anthony Blake and Felipe Rojas in settlement of their cases.

Respondent disbursed funds to himself that he was not entitled to receive on June 20, 1996, in the amount of Four Thousand Dollars (\$4,000.00).

Respondent disbursed funds to himself that he was not entitled to receive on June 23, 1996, in the amount of Four Thousand Dollars (\$4,000.00).

Respondent disbursed funds to himself that he was not entitled to receive on June 25, 1996, in the amount of Eight Thousand Dollars (\$8,000.00).

Respondent disbursed funds to himself that he was not entitled to receive on

June 30, 1996, in the amount of Four Thousand Dollars (\$4,000.00).

IV.

By failing to pay his clients medical provider, Sloan Medical Clinic, for providing medical services, in accordance with his letters of protection, Respondent engaged in conduct in violation of Rules 1.14(a)[a lawyer shall hold funds and other property belonging in whole or in part to client or third persons in a lawyer's possession separate from the lawyer's own property]; 1.14(b)[a lawyer shall, upon receiving funds or other property in which a client or third person has an interest, promptly notify the client or third person and render a full accounting upon request]; and 1.14(c)[a lawyer shall keep funds or other property in which both the lawyer and another person claim interests separate until there is an accounting and severance of their interests] of the Texas Disciplinary Rules of Professional Conduct, and of Rule 1.06(Q) of the Texas Rules of Disciplinary Procedure.

By disbursing to himself funds that he was not entitled to receive, Respondent engaged in conduct in violation of Rules 1.14(a)[a lawyer shall hold funds and other property belonging in whole or in part to client or third persons in a lawyer's possession separate from the lawyer's own property]; 1.14(c)[a lawyer shall keep funds or other property in which both the lawyer and another person claim interests separate until there is an accounting and severance of their interests]; and $8.04(a)(3)[a lawyer shall not engage in conduct involving dishonesty, deceit, fraud, or misrepresentation] of the Texas Rules of Disciplinary Procedure and of Rule 1.06(<math>\Omega$) of the Texas Rules of Disciplinary Procedure.

The complaint which forms the basis of this lawsuit as hereinabove set forth was brought to the attention of the Office of the General Counsel of the State Bar of Texas by the filing of a complaint by Kristin Way on or about October 30, 1995.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined by reprimand, suspension, or disbarment, as the facts shall warrant; and that Petitioner have such other and further relief to which entitled, including costs of Court and attorney's fees.
