COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas, complaining of Respondent, George A. Young, showing the following to the Court:

1.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex.Gov't Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed with the State Bar of Texas on or after September 6, 1996.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas. An officer may serve citation on Respondent at his business address located at 1010 Houston Bar Center Building, 723 Main Street, Houston, Texas 77002-3311.

In 1992, Albertha Toliver hired Respondent to represent her son, Theodule Bossett in a civil matter. Over the course of the representation, Respondent neglected the case, and failed to perform any meaningful work for his client. As a result, the alleged claim became time barred by the applicable statute of limitations.

IV.

By failing to perform any meaningful work for his clients, and allowing their claims to become time barred by the statute of limitations, Respondent engaged in conduct in violation of Rule 1.01(b)(1)[neglecting a legal matter entrusted to the lawyer] of the Texas Disciplinary Rules of Professional Conduct and Rule 1.06(Q) of the Texas Rules of Disciplinary Procedure.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined by reprimand, suspension, or disbarment, as the facts shall warrant; and that Petitioner have such other and further relief to which entitled, including costs of Court and attorney's fees.
