West Texas Legal Services, Petitioner, pursuant to article XIII, Section 2 (c), of the Texas State Bar Rules, petitions this Court to certify it as an approved legal assistance organization for the purpose of allowing eligible lawyers to practice under article XIII of the Texas State Bar Rules and as grounds would show:

- Petitioner is a Texas, not-for-profit organization. It was formed in December 17, 1951, for the purpose of providing free legal services to indigent persons within 103 Counties.
