DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Cindy D. Purinton (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. § 81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of, and has her principal place of practice in, Tarrant County, Texas. An officer may serve citation on Respondent at 1521 N. Cooper Street, Suite 200, Arlington, Tarrant County, Texas 76011.

FIRST CAUSE OF ACTION

III.

Respondent was retained by Dalmas Taylor (hereinafter referred to as "Complainant") in July, 1995, to represent him in pursuit of his claims, as buyer, against the seller of residential real property. In or about July or August, 1995, Respondent sent a demand letter on behalf of Disciplinary Petition - Page 1 of 3

Complainant alleging fraud and failure to disclose the residential real property defects as required under the Texas Property Code. Respondent received seller's response dated August 26, 1995, a copy of which she forwarded to Complainant on September 8, 1995. On October 20, 1995, Respondent sent a second demand letter on behalf of Complainant to seller. When it appeared that the issue would not resolve, Complainant made several requests for Respondent to file a lawsuit on his behalf against seller. On March 21, 1996, no lawsuit had been filed, and Complainant wrote Respondent requesting that she respond within a specified time period and explain why no lawsuit had been filed.

On April 8, 1996, Respondent wrote to Complainant requesting a \$750.00 retainer and his signature on a contract. On April 15, 1995, Complainant signed and returned to Respondent the Contract for Attorney Services. Several months passed without communication (either verbal or written) from Respondent. In July, 1996, Complainant informed Respondent that he was selling his house and would be leaving Texas by the end of August. Respondent assured Complainant that would not be a problem and that Complainant would hear from her soon. In mid-August, 1996, Complainant called Respondent's office and left a message on an answering machine that he wanted a refund of his \$750.00 and his file if he did not receive copies of the requested work within a week. Complainant moved to Pennsylvania on August 29, 1996, without hearing from Once settled in Pennsylvania, on September 23, 1996, Complainant wrote Respondent. Respondent and again requested a refund of his \$750.00 retainer and return of his personal files to him. Complainant received no response to his letter. On November 6, 1996, Complainant wrote Respondent again requesting the refund and his file. On January 21, 1997, Complainant filed a grievance complaint against Respondent. Afterwards, on January 30, 1997, Complainant received his file from Respondent. To date, Complainant has not received a refund of his \$750.00 retainer.

Such acts and/or omissions on the part of Respondent as are described in Paragraph III hereinabove which occurred on or after January 1, 1990, constitute conduct violative of Rules 1.01(b)(1), 1.03(a), 1.14(a), 1.14(b), and 1.14(c) of the Texas Rules of Professional Conduct.

V.

The complaint which forms the basis of the cause of action hereinabove set forth was brought to the attention of the Office of the General Counsel of the State Bar of Texas by a complaint filed by Dalmas Taylor on or about January 21, 1997.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
