ORIGINAL DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas (hereinafter referred to as "Petitioner"), complaining of Respondent, ROBERT T. WALLACE, (hereinafter referred to as "Respondent"), and would show the Court the following:

I. NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the State Bar Act, the Tex.Gov't Code Annotated. §81.001, *et seq.* (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure. The complaint that forms the basis of this Original Disciplinary Petition were filed on or after May 1, 1992.

II. <u>VENUE</u>

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas; therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of Disciplinary Procedure. Respondent at his business address located at P.O. Box 301003, Houston, Harris County, Texas 77230-1003.

III. <u>CAUSE OF ACTION</u>

On or about September 11, 1996, the Respondent was employed for representation in a personal injury case on a contingency fee agreement. Complainant tried to contact Respondent by phone as to the status of her case and found that Respondent had closed his office without notifying her. Respondent failed to inform the Complainant that he was no longer representing her daughter's personal injury case.

The Respondent was notified of the allegations on or about November 26, 1997. There was no response to the allegations at that time. In early January, the Respondent appealed the classification by Petra V. Contreras, Investigator, State Bar of Texas. On January 21, 1998, the Board of Disciplinary Appeals denied the Respondent's appeal. The Respondent has since failed to respond to the allegations against him.

IV.

The complaint that forms the basis of this cause of action was brought to the attention of the Office of the General Counsel of the State Bar of Texas by Emily Robin's filing of a complaint on or about November 3, 1997.

V. <u>RULE VIOLATIONS</u>

The acts and/or omissions of Respondent described in Paragraph III above which occurred on or before January 1, 1990, constitute conduct in violation of Rules 1.01(b)(1) [for neglecting a legal matter entrusted to the lawyer]; 1.01(b)(2) [frequently failed to carry out completely the obligations owed to the client]; 1.03(a) [a lawyer shall keep a client

reasonably informed about the status of a matter and promptly comply with reasonable requests for information]; 8.01(b) [for knowingly failing to respond to a lawful demand for information from a disciplinary authority]; and 8.04(a)(8) [for failing to timely furnish a district grievance committee a response or other information as required unless he/she timely asserts a privilege or other legal ground for failure to do so].

<u>PRAYER</u>

WHEREFORE, PREMISES CONSIDERED, Petitioner, COMMISSION FOR LAWYER DISCIPLINE, respectfully prays that this Court discipline Respondent, ROBERT T. WALLACE, by reprimand, suspension, or disbarment, as the facts shall

warrant; restitution; and all other relief to which Petitioner may show itself to be justly entitled, including costs of court and attorneys' fees.

Touche Ross Co., 946 S.W.2d 862 (Tex. App. - Houston [14th Dist.] 1997), which requires that all proceedings incident to a case occur in the county of proper venue. If not, I would respectfully request that an alternate appointment be made.

Once a trial judge has been appointed, please forward the original and two (2) copies of the Disciplinary Petition, the filing fee check, also enclosed herewith, and the Court's appointing order to the District Clerk of Harris County, Texas, with the request that the suit be filed, service be obtained, and a file-marked copy of the petition be returned to the undersigned.
