PETITIONER'S ORIGINAL DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

Comes now, Petitioner, COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas, complaining of Respondents, RICHARD L. MACON and KAREN KROESCHE GULDE, and in support thereof would respectfully show the Court the following:

Parties

Petitioner is the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas. Respondent, RICHARD L. MACON, State Bar No. 12787500; and Respondent, KAREN KROESCHE GULDE, State Bar No. 08612150, at all times relevant to this cause of action, are attorneys licensed to practice law in the State of Texas and are members of the State Bar of Texas. Respondents are residents of San Antonio, Bexar County, Texas and may be served with process at 300 Convent Street, Suite 1500, San Antonio, Bexar County, Texas 78205, their usual place of employment.

<u>Venue</u>

Respondents maintain their principal place of law practice in Bexar County, Texas. The alleged acts of professional misconduct occurred in whole or in part in Bexar County, Texas. Accordingly, pursuant to Texas Rules of Disciplinary Procedure 3.03, venue is proper in Bexar County, Texas.

Professional Misconduct

I.

Petitioner brings this disciplinary action pursuant to State Bar Act, Tex. Gov't. Code Ann., Sec. 81.001, et seq. (Vernon 1988), the <u>Texas Disciplinary Rules of Professional Conduct</u> and the <u>Texas Rules of Disciplinary Procedure</u>. The complaints which form the basis of this action were filed on or about July 3, 1997 by the State Bar of Texas. The acts and conduct of Respondent, as hereinafter alleged, constitute professional misconduct.

Count I -- Richard L. Macon

Π.

Respondent, at all times relevant to this cause of action, is an attorney licensed to practice law in the State of Texas and is a member of the State Bar of Texas.

III.

Users System Services, Inc., USSI Computer Services, Inc., and Ron Landreth ("USSI plaintiffs") hired the law firm of Akin, Gump, Strauss, Hauer & Feld, L.L.P to sue News America Publishing, Inc., and individual defendants, Eugene M. McKeown, Sandra S. Shafer and Don Frazier ("News America defendants"). Respondent, R.L. Macon, was a senior partner in the law firm of Akin, Gump and served as lead counsel for the USSI plaintiffs. The USSI plaintiffs sued for damages alleging the News America defendants breached contracts and tortiously interfered with the business relations of USSI.

IV.

On or about May 12, 1995, Respondent, R.L. Macon, as a partner and supervising lawyer encouraged or knowingly permitted a subordinate associate attorney, Respondent Karen Kroesche

Gulde, to communicate about the subject of the ongoing litigation with an adverse party, Don Frazier, when Respondent, R.L. Macon, and Respondent, K.K. Gulde, knew Mr. Frazier's attorney was still the attorney of record. Respondent, R.L. Macon, and Respondent, K.K. Gulde, made no attempt to obtain the consent from Mr. Frazier's attorney prior to the unauthorized communication.

Count II -- Karen Kroesche Gulde

V.

Respondent, at all times relevant to this cause of action, is an attorney licensed to practice law in the State of Texas and is a member of the State Bar of Texas.

VI.

Users System Services, Inc., USSI Computer Services, Inc., and Ron Landreth ("USSI plaintiffs") hired the law firm of Akin, Gump, Strauss, Hauer & Feld, L.L.P to sue News America Publishing, Inc., and individual defendants, Eugene M. McKeown, Sandra S. Shafer and Don Frazier ("News America defendants"). Respondent, K.K. Gulde, was an associate attorney in the law firm of Akin, Gump and worked under the direct supervision of Respondent, R.L. Macon, in the representation of the USSI plaintiffs. The USSI plaintiffs sued for damages alleging the News America defendants breached contracts and tortiously interfered with the business relations of USSI.

VII.

On or about May 12, 1995, Respondent, K.K. Gulde, communicated about the subject of the ongoing litigation with an adverse party, Don Frazier, when Respondent knew Mr. Frazier's attorney was still the attorney of record. Respondent, K.K. Gulde, made no attempt to obtain the consent from Mr. Frazier's attorney prior to the unauthorized communication.

Disciplinary Rules of Professional Conduct

VIII.

The conduct of Respondents, R.L. Macon and K.K. Gulde described above was in violation

of the following Texas Disciplinary Rules of Professional Conduct:

Rule 4.02(a) -- In representing a client, a lawyer shall not communicate or cause or encourage another to communicate about the subject of the representation with a person * * * the lawyer knows to be represented by another lawyer regarding that subject, unless the lawyer has the consent of the other lawyer or is authorized by law to do so.

Rule 5.01(a) -- A lawyer shall be subject to the discipline because of another lawyer's violation of these rules of professional conduct if the lawyer is a partner or supervising lawyer and orders, encourages, or knowingly permits the conduct involved.

Rule 5.01(b) -- A lawyer shall be subject to the discipline because of another lawyer's violation of these rules of professional conduct if the lawyer is a partner in the law firm in which the other lawyer practices * * * or has direct supervisory authority over the other lawyer, and with knowledge of the other lawyer's violation of these rules knowingly fails to take reasonable remedial action to avoid or mitigate the consequences of the other lawyer's violation.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays that a judgment of professional misconduct be entered against Respondents imposing an appropriate sanction as the facts shall warrant and that Petitioner have such other relief to which it is entitled, including, but not limited to, costs of court, all direct expenses associated with these proceedings and reasonable attorney's fees as provided in Rule 1.06(T)(8)(b) of the Texas Rules of Disciplinary Procedure.
