TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, CHARLES R. LEPLEY, State Bar Card No. 12219050 (hereinafter called "Respondent"), showing the Court:

I

Pursuant to Rule 190.1, Texas Rules of Civil Procedure, discovery in this case is governed by Discovery Control Plan -- Level 2, as provided in Rule 190.3, T.R.C.P.

П.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after September 20, 1998.

Ш.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Williamson County, Texas. Respondent is represented by counsel herein. Service on Respondent is not necessary at this time as counsel has agreed to accept service on behalf of Respondent.

Respondent was retained in early 1997 by Sandra Tennant (hereinafter called "Complainant") for the purpose of reducing to judgment child support arrears, including medical reimbursement from previous orders. Complainant's ex-husband was served in November, 1997, with a motion to enforce, modify support and to transfer the case from Bexar County to Travis County, Texas. Although Complainant's ex-husband failed to answer and wholly defaulted, Respondent did not obtain a setting for a hearing on the matter until February 19, 1998, for the date of March 25, 1998. After the March 25, 1998, hearing, Respondent submitted an order containing incorrect calculations of the amounts owed. Respondent thereafter failed to prepare and submit a corrected order until June, 1998. Respondent scheduled an additional hearing approximately four months later, in October, 1998, for entry of his corrected order. Because the court required a review of the record of the original March 25th hearing, a final order was not signed until December 10, 1998, approximately one year after Complainant's ex-husband defaulted in the case.

V.

Such acts and omissions on the part of Respondent as are described in Paragraph IV hereinabove, constitute professional misconduct in violation of Rule 1.01(b)(1) [a lawyer shall not neglect a legal matter entrusted to the lawyer] of the Texas Disciplinary Rules of Professional Conduct and Part 1.06(Q)(1) of the Texas Rules of Disciplinary Procedure.

VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Sandra Tennant filing a complaint on or about September 20, 1998.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other and further relief to which entitled, including costs of court and attorneys fees.
