#### **Parties**

Petitioner is the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas. Respondent, ROBERT A. KUGLE, State Bar Number 11755500, was, at the time the following alleged acts of professional misconduct occurred, an attorney licensed to practice law in the State of Texas and a member of the State Bar of Texas. Respondent may be served with process at Riverview Towers, 111 Soledad, Suite 700, San Antonio, Bexar County, Texas 78205, his usual place of business.

#### Venue

At the time the alleged professional misconduct occurred, Respondent maintained a law office in San Antonio, Bexar County, Texas. The alleged acts of professional misconduct occurred in whole or in part in Bexar County, Texas. Accordingly, pursuant to Texas Rules of Disciplinary Procedure 3.03, venue is proper in Bexar County, Texas.

## **Discovery Level Designation**

I.

Pursuant to Tex.R.Civ.P. 190.1, Petitioner designates that discovery in this action should proceed pursuant to Level 2 (Tex.R.Civ.P. 190.3).

#### **Professional Misconduct**

II.

Petitioner brings this disciplinary action pursuant to State Bar Act, Tex. Gov't. Code Ann., Sec. 81.001, et seq. (Vernon 1988), the <u>Texas Disciplinary Rules of Professional Conduct</u> and the <u>Texas Rules of Disciplinary Procedure</u>. The complaint which forms the basis of this action was filed on or about September 1, 1998 by Nell Rose Franklin. The acts and conduct of Respondent, as hereinafter alleged, constitute professional misconduct.

III.

On or about April 1, 1997, Respondent was hired to represent Edward and Nell Franklin for Personal injury and property damage resulting from an oil well blowout occurring in Lee County, Texas that occurred on July 13, 1996.

IV.

During the representation of Mr. and Mrs. Franklin, Nell Franklin attempted to contact Respondent several times by telephone and left messages for Respondent to return her calls. Respondent has never returned the calls. Nell Franklin wrote several letters to the Respondent to which the respondent has not responded.

V.

During the pendency of Respondent's Law Firm's representation of Mr. And Mrs. Franklin, several attorneys who were assigned to the matter left the firm and other attorneys were assigned. The Respondent failed to advise Mr. and Mrs. Franklin of these changes in attorneys or in the change of their point of contact within the firm. Respondent failed to take reasonable steps to insure his clients were aware of the status of their case and the change in assignment of attorneys to permit informed decisions regarding representation.

VI.

The conduct of Respondent described above constitutes violations of the following Disciplinary Rules:

Rule 1.03(a) -- A lawyer shall keep a client reasonable informed about the status of a matter and promptly comply with reasonable requests for information.

Rule 1.03(b) -- A lawyer shall explain a matter to the extent reasonably necessary to permit the client to make informed decisions regarding the representation.

#### **PRAYER**

WHEREFORE, PREMISES CONSIDERED, Petitioner prays that a judgment of professional misconduct be entered against Respondent imposing an appropriate sanction as the facts shall warrant and that Petitioner have such other relief to which it is entitled, including costs of court, litigation expenses and attorney's fees.

As a practical matter, I would respectfully suggest that you inquire with the judge to be appointed as to: (1) whether he or she will be able to comply with the 180 day deadline by which the case must be set for trial as set forth in Section 3.07 of the Texas Rules of Disciplinary Procedure; and (2) whether he or she can accommodate compliance with Mellon Service Co., et al v. Touche Ross Co., 946 S.W.2d 862 (Tex.App.- Houston [14th Dist.] 1997), which requires that all proceedings incident to a case occur in the county of proper venue. If not, I would respectfully request that an alternate appointment be made.

Once a trial judge has been appointed, please forward the original and three (3) copies of the

Disciplinary Petition, the filing fee check, also enclosed herewith, and the Court's appointing order to the District Clerk of Bexar County, Texas, with the request that the suit be filed, service be obtained, and a filemarked copy of the petition returned to the undersigned.
