




# SB 31 Guardianship, Abuse, Fraud, and Exploitation Deterrence Program

By Sen. Zaffirini/Rep. Smithee

- Expands OCA's current Guardianship Compliance Project Statewide.
- Requires OCA to engage guardianship compliance specialists to review and monitor reports and accounts of guardians for potential abuse, fraud or exploitation and report findings to appropriate court.
- Fully funded in the budget.



## HB 2384 Judicial Pay Increase

By Rep. Leach/ Sen. Huffman

#### **Tiered Pay System Based on Longevity**

#### Years of Service

- **0-4 years of service** receive current base pay:
  - \$140k for district judges, \$154K for COA, \$168K for SC/CCA
- 4-8 years of service receive 110% of base pay:
  - \$154k for district judges, \$169,400 for COA, \$184,800 for SC/CCA )
- 8-12 years of service receive 120% of base pay:
  - •\$168k for district judges, \$184,800 for COA, \$201,600 for SC/CCA
- 12 plus years of service receive increased longevity pay from 3.1% to 5%
- •Retirement Contribution increased from 7.5% to 9.5%

#### **Other Salaries**

- •Child Support/Child Protection judges receive 90% of the base salary of a district judge
- •CCAL Judges and Prosecutors on tiered system



## SB 40 Judicial Disaster Changes

By Sen. Zaffirini/Rep. Leach

- Extends emergency orders for up to 90 days and allows chief justice to renew orders instead of full court.
- Allows Presiding Judge of Administrative Region to authorize court to operate in another precinct or county.
- Allows Presiding Judge of Administrative Region to designate the terms and sessions of the court in the region if the court is precluded from holding its terms by a disaster.





## TJC Mental Health Legislation

### HB 601

By Rep. Price/Sen. Zaffirini

- SB 1326 Clean-up bill from 85<sup>th</sup> Session
- Magistrate can order a defendant interviewed upon determination of mental illness.
  - May be interviewed by service provider that contracts with Jail to provide MHIDD services.
  - Interviewing entity must provide report of interview and information collected.
- TJC to adopt rules on reporting.
- Requires mental health records and screening reports to be transferred to TDCJ upon incarceration.

#### HB 598

By Rep. Price/Sen. Zaffirini

• Adds part-time masters, magistrates, and associate judges to the list of officials eligible for judicial and court personnel training funds.

### SB 362 Court Ordered Mental Health Services

By Sen. Huffman/Rep. Price

Addresses multiple issues related to court ordered mental health treatment:

- Clarifies conditions under which a judge may order
  - temporary outpatient;
  - extended inpatient; or
  - outpatient mental health services.
- allows a court to set a status conference with the patient, the patient's attorney, and the person designated as responsible for the patient's court-ordered outpatient mental health services.
- requires publicly funded facilities to coordinate admission, treatment plan, discharge plan with LMHA and provide medication upon discharge.
- requires additional judicial training related to court-ordered outpatient mental health services at least once a year.
- directs the Supreme Court to adopt rules related to streamlining court processes connected to emergency detention.



### SB 562 Manifest Dangerousness By Sen. Zaffirini/ Rep. Price

- Requires the court that civilly committed a defendant, upon receiving notice from a facility or outpatient treatment center of intent to release a committed defendant, to hold a hearing to determine if release is appropriate.
- Requires the Health and Human Services Commission (HHSC) to transfer a defendant from a maximum security unit to a nonmaximum security unit if a review board determines the defendant is not manifestly dangerous.
- Allows certain individuals to expunge files and records relating to an arrest if the person completes a mental health court program.
- Requires counties with a population over 200,000 to create a mental health court program if they receive funding for program.



## Uniform Case Management System




- \$29.7 Million to OCA to fund a uniform case management system.
- Focus on counties under 20K.
  - Necessary to comply with Federal order in CPS cases.
  - Part of Governor's School Safety Plan to assist with mental health and protective order reporting to NICS.
  - Provides magistrates with immediate access to critical information.
  - Will assist counties in reporting case level data.



## HB 2955 Specialty Court Oversight

By Rep. Price/ Sen. Zaffirini

- OCA to provide to specialty courts:
  - technical assistance;
  - monitor the programs for compliance with best practices; and
  - coordinate the exchange of information between the specialty courts, the judiciary and the Governor's Criminal Justice Division.
- Moves Texas closer to national practices with centralized administration of specialty courts within the judiciary to better advance quality assurance, training, funding, research, technology, and advocacy goals.





## SB 2342 Court Jurisdiction

By Sen. Creighton/ Rep. Leach


- Increases Justice of the Peace and Constitutional County Court civil Jurisdiction up to \$20,000.
- Increases County Court at Law civil jurisdiction up to \$250,000.
- Requires 12 person jury in County Court at Law when the case in controversy exceeds \$250,000.
- Requires Supreme Court to amend expedited rules to promote the prompt, efficient, and cost-effective resolution of civil actions filed in county courts at law in which the amount in controversy does not exceed \$250,000.



## SB 1887 Dually Involved Youth

By Sen. Huffman/ Rep. Murr

- Allows a court exercising juvenile jurisdiction to transfer a juvenile case to the court with jurisdiction over a youth's CPS case.
- Spurred by the "one family/one judge" approach to improve case outcomes for dually-involved youth





## SB 489 Court Security Updates

By Sen. Zaffirini/Rep. Smithee

- Closes loopholes that allowed judges personal information to be available to the public through the Texas Ethics Commission and County Clerk online and in person.
- Requires OCA to publish a report to the legislature detailing the court security activities supported by the Judicial Security Division including:
  - technical aspects of providing court security;
  - court security training provided or required by the Division;
  - the sufficiency of Division resources to evaluate and monitor court security; and
  - the adequacy of funding to maintain court security.

## SB 346 Criminal Court Costs Consolidation

By Sen. Zaffirini/ Rep. Leach

- Simplifies the difficult-to-administer criminal court cost system and remedies potential constitutional issues using the *Salinas* line of cases by redirection money to a legitimate criminal justice purpose or classifying a statutory cost correctly as a fine or reimbursement of service.
  - No negative impact on local or state revenue
  - Convicted defendant now pays two court costs:
    - State Consolidated Court Cost
    - Local Consolidated Court Cost
  - Plus
    - Fines
    - Reimbursement fees

#### In Addition:

- Makes changes to collection of court costs and fees for defendants who are financially unable to pay:
  - Requires judge to hold a hearing to determine whether portion of fines, fees, costs create undue hardship.
  - Satisfy them through later due date, community service, waiving fine or combination.
  - Allows court to reconsider on own motion the waiver of costs if defendant has financial resources to do so.



## HB 3040 Judicial Selection Commission

#### By Rep. Hunter/Sen.Huffman

- Texas Commission on Judicial Selection created to study and review the method by which judges and justices are selected for office.
  - Staffed by OCA
- Study options:
  - lifetime appointment;
  - appointment for a term;
  - appointment for a term, followed by a partisan election;
  - appointment for a term, followed by a nonpartisan election;
  - appointment for a term, followed by a nonpartisan retention election;
  - partisan election for an open seat, followed by a nonpartisan retention election for incumbents; and
  - any other method or combination of methods for selecting a judicial officer described by the bill.
- Membership:
  - 4 members appointed by the governor
  - 4 members appointed by the lieutenant governor
  - 4 members appointed by House speaker
  - 1 member appointed by the chief justice of the Supreme Court of Texas;
  - 1 member appointed by the presiding judge of the Texas Court of Criminal Appeals
  - 1 member appointed by the board of directors of the State Bar of Texas
- Report due to Legislature and Governor by December 31,2020. Commission abolished on January 2, 2021.

- OCA received funding to renew weighted caseload study to determine where new district and county courts should be located.
- Repeals collection improvement program.

## 86<sup>th</sup> Legislative Session Appropriation Summary


Overall baseline budget request totaled \$669 million (excluding retirement and benefits).

Judiciary courts/agencies submitted exceptional item requests totaling \$166 million bringing total request to \$835 million.

Requested an additional 69.0 FTEs in exceptional items.

\$799 million appropriated to Article IV. 1,540.6 FTEs, an increase of 63.8 FTEs. Including retirement and benefits – \$955 million, a \$72 million or 9% biennial increase. Contingency riders added approximately \$41 million to the conference committee report. These totals include IACs.

NOTE: Object size is proportional to the percentage of recommended All Funds appropriation for all articles. SOURCE: Legislative Budget Board.



## Conference Committee Items of Significance SUPREME COURT

- Salary increase for senior staff attorneys, law clerks, clerks and administrative staff.
- Judicial pay increase HB 2384 \$473K
- Basic Civil Legal Services increased by 17.6 million in GR to provide funding at 2010-2011 levels. \$68 million total funding in GAA.
- Increase of \$3 million in GR to provide additional legal services to veterans and their immediate families. \$6 million total funding.
- An additional \$400K in GR-D 5010 Sexual Assault Program Account funding. Restores BCLS appropriations for sexual assault survivors to \$10.0 million.
- \$250,000 in GR for the development of a training program to educate and inform judges and their staffs on available mental health resources.





### **COURT of CRIMINAL APPEALS**

- Salary increase for senior staff attorneys, law clerks, clerks and administrative staff.
- Additional \$3.5 million in Judicial Training Fund No. 540 (an estimated fund) to match the CPA's Biennial Revenue Estimate.
- \$250,000 in GR for the development of a training program to educate and inform judges and their staffs on available mental health resources.
- Judicial pay increase HB 2384 \$515K



### **14 INTERMEDIATE COURTS OF APPEALS**

- Approved for one staff attorney to assist visiting appellate judges with processing cases. FTE is residing in Office of Court Administration's budget. \$258K
- Rider that allows courts of appeals to use CPA Visiting Judge funds to employ or contract for a staff attorney to assist judges in cases that are in addition to their ordinary case load. (a CPA-Judiciary rider)
- Judicial pay increase HB 2384 \$2.9 million



### STATE PROSECUTING ATTORNEY

- Salary increase for asst. state prosecutors and administrative assistant.
- Judicial pay increase HB 2384 \$8,167

### STATE COMMISSION ON JUDICIAL CONDUCT

• Salary increase for all staff and increase the Executive Director to exempt group 4.

### STATE LAW LIBRARY

- Salary increase for staff, assistant director and increase the Executive Director to Exempt group 2.
- \$170,000 in GR to maintain remote access to digital legal reference materials at current service levels.





### **OFFICE OF CAPITAL AND FORENSIC WRITS**

- Salary increase for attorneys and mitigation specialists, and increase the Executive Director to Exempt group 4.
- \$965K for three attorneys (two dedicated to representing inmates in non-capital cases where questionable forensic science contributed to a conviction), a mitigation specialist, travel, operating and litigation expenses.



- \$5 million and 28.0 FTEs for the Guardianship Compliance Program.
- \$3.7 million and 18.0 FTEs for 9 new Child Protection courts. (76 total children's courts)
- \$300K for lump sum annual leave payouts for children's court staff. (57% of CSC; 20% CPC can retire)
- \$29 million for the Uniform Case Mgmt System. More than half is to be paid from the e-filing account.



### **OFFICE OF COURT ADMINISTRATION**

- Forensic Science Commission estimated appn. authority for GR-D account providing access to all licensing revenues.
  \$1.4 million biennial budget.
- Estimated appropriation authority restored for e-Filing account providing access to an additional \$15.8 million.
- \$2.2 million for HB 2384 judicial pay bill to increase salaries of children's court associate judges.
- \$258K for one staff attorney to assist the intermediate appellate courts visiting judges in complex cases.



- \$300K to update the weighted case load study, currently 12-13 years old. (SB 891)
- \$67K to create a public website for inventorying public citations and other legal notices. (SB 891)
- \$80K into update the software system tracking judicial branch certifications in order to add two new court reporter licensing categories. (SB 891)
- \$300K to create a tracking system for various data associated with suits affecting the parent-child relationship. (SB 560)



## Conference Committee Items of Significance OFFICE OF COURT ADMINISTRATION

- \$325K out of e-Filing account to create a internet based protective order registry (SB 325).
- \$281K and 2.0 FTEs for resources and support for the Texas Commission on Judicial Selection. (HB 3040)

### **TX INDIGENT DEFENSE COMMISSION**

- Additional \$28 million appropriated. Includes \$5 million for grants to public defender offices to develop a pilot project for the early identification and specialized representation of indigent defendants with mental illness.
- Elimination of cap on administrative expenses and FTE limit of 11. Estimated authority was not restored.



### **COMPTROLLER JUDICIARY SECTION**

- Judicial pay bill HB 2384 \$24 million for salary increases for district judges, district attorneys, professional prosecutors, felony prosecutors, and county attorneys. Additional \$4 million for judicial retirement system.
- \$9.4 million for assistant prosecutor longevity pay to offset anticipated decrease in revenue to the AP supplement fund and increase in number of prosecutors that will be eligible.
- \$252K and 1 FTE for a new prosecutor position within the Juvenile division that focuses on sexual assault cases.
- \$3.3 million due to the creation of new judicial districts, statutory courts and changes within the professional prosecutors act. (SB 891)





#### FY 2020-2021 Total Funding - Appellate Courts










## FY 2020-2021 Total Funding - Judicial Agencies excluding the Appellate Courts
