# Report from the Texas Indigent Defense Commission (TIDC) for the November 15, 2019 Texas Judicial Council Meeting

### TIDC Board and Committee Meetings

The TIDC <u>Full Board</u> met August 29<sup>th</sup> to consider

Improvement Grant applications, approve contracts, and discuss the FY20 budget. This meeting marked Williamson County Commissioner Valerie Covey's first meeting as a board member.

The June and August Board meetings were historic. TIDC invested in a Travis County Public Defender Office,



a Harris County MAC, a 27-county Padilla pilot project, a randomized controlled trial to study counsel at magistration, rural regional public defender offices, and the Regional Public Defender Office for Capital Cases (RPDO), all while increasing formula grant funding.

The next Policies and Standards Committee meeting is Friday, December 13<sup>th</sup> at 10:30 a.m. in the TIDC 2<sup>nd</sup> Floor Conference Room. The next Full Board meeting is Friday, December 13<sup>th</sup> at 1:30 p.m. in the Tom C. Clark Building, 1<sup>st</sup> Floor Conference Room.

## Staff Activities

In addition to its normal monitoring, grants administration, and data collection, TIDC staff has been involved in the following:

• In mid-July, **Geoff Burkhart** met with County Judge **Sarah Eckhardt** to discuss the Public Defender Oversight Committee for Travis County.
