2018 Judicial Compensation Commission Recommendations

- 15% Salary increase for all State Judges.
- Require the Commission's salary recommendations be included as an exceptional item in the Comptroller Judiciary Section's Legislative Appropriation Request to ensure a formal mechanism is in place for legislators to consider the Commission's recommendations;
- Reduce the number of years required to receive judicial longevity pay from sixteen years of service to four years of service and to provide the judge or justice 0.2 percent of their current monthly state salary for every year of judicial service; and
- Fund an increase in the salaries of the Children's Court Associate Judges at ninety percent of a district judge's salary.



2019 Judicial Pay Increase

Tiered Pay System Based on Longevity

Years of Service

- 0-4 years of service receive current base pay:
 - \$140k for district judges, \$154K for COA, \$168K for SC/CCA
- **4-8 years of service** receive 110% of base pay:
 - \$154k for district judges, \$169,400 for COA, \$184,800 for SC/CCA)
- 8-12 years of service receive 120% of base pay:
 \$168k for district judges, \$184,800 for COA, \$201,600 for SC/CCA
- 12 plus years of service receive increased longevity pay from 3.1% to 5%

Other Salaries

•Child Support/Child Protection judges receive 90% of the base salary of a district judge

•CCAL Judges and Prosecutors on tiered system






