#### **COMMENCEMENT OF MEETING**

On February 20, 2015, Chief Justice Nathan L. Hecht called the meeting<sup>1</sup> of the <u>Texas Judicial</u> <u>Council</u> ("Council") to order at approximately 10:00 a.m. in the courtroom of the <u>Supreme Court</u> <u>of Texas</u> ("SCOT") in Austin, Texas.

With a quorum present, Chief Justice Hecht called for a motion to approve the previous meeting minutes. Minutes were voted upon. After vote, the <u>November 14, 2014</u> meeting minutes were adopted.

## **REPORTS AND ACTION ITEMS**

## **Update regarding Tech for Justice Hackathon**

Mr. Slayton provided information regarding the <u>Tech for Justice Hackathon</u>.

#### Texas Indigent Defense Commission Report

Jim Bethke, Executive Director, Texas Indigent Defense Commission (TIDC) reported on <u>HB 48</u> and <u>SB 81</u>, both relating to the creation of a commission to review convictions after exoneration and to prevent wrongful convictions.

Next, Wesley Shackelford, Deputy Director/Special Counsel, TIDC, reported on <u>SB 260</u>, relating to caseloads for attorneys who are appointed to represent indigent defendants in criminal cases, <u>SB 316</u>, relating to the prioritization of certain available legal defense services when appointing representation for an indigent defendant in a criminal case, <u>HB 1346</u>, relating to the representation of certain indigent applicants for a writ of habeas corpus, and <u>SB 544</u>, relating to reimbursement for the costs of legal services provided to an indigent defendant in a criminal case.

Presiding Judge Sharon Keller reported that the commission would hold a grant application training seminar.

Edwin Colfax, Grant Program Manager, TIDC, reported on the Client Choice Pilot Project, noting that the Justice Management Institute has been contracted to write an impact assessment after the program ends in about a year.

Judge Keller reported on publications issued since the Council last met, including the Commission's Annual and Expenditure Report for FY 2014.

Mr. Bethke followed with a report on the findings of the state's first criminal defense weighted caseload study that have been published. The report, <u>Guidelines for Indigent Defense Caseloads</u>, is posted on the commission's website.

#### Presentation of Guardianship Study Findings

Scott Griffith, Director for Research and Court Services, OCA, presented the guardianship study findings: <u>Texas Guardianship Cases</u>: <u>Improving Court Processes and Monitoring Practices in Texas Courts</u>. He also discussed the recently released report <u>Asset Forfeiture in Texas</u>: <u>DPS and</u>

<u>County Interactions</u>. Both are posted on the OCA website. He acknowledged Judge Spencer and Aurora Zamora, Court Services Consultant, OCA, for their respective work on these reports.

#### **Report of the FY 14 Statistical Information for the Texas Courts**

Mr. Slayton provided the Council with <u>highlights</u> of the FY 2014 Annual Statistical Report for the Texas Courts.

#### Legislative Update

Mr. Slayton reviewed the status of current legislative resolutions.

#### New Business

Judge Rodriguez expressed appreciation for the OCA, TIDC, and related participants.

#### Next Meeting

Chief Justice Hecht announced that the next meeting of the Council will be held on June 12, 2015.
