









On or about July 19, 1991, Susan Meek ("Meek") hired Respondent to take over her representation in an ongoing lawsuit. At that time, Meek informed Respondent that she had been served with interrogatories, requests for production, and requests for admissions, which were due on or about July 25, 1991. Also at that same time, Meek gave Respondent her entire client file, which included handwritten answers to the discovery propounded on her. Respondent, acting as Meek's attorney, even placed a call with the opposing counsel, requesting an extension on the deadline for the discovery. Respondent represented to Meek that the responses to the discovery had been timely filed, when in fact Respondent failed to timely file the responses, and therefore caused the request for admissions to be deemed against Meek. Meek was not aware that the admissions had been deemed against her, until in or around May 1992, when she looked at the Court's file.

Respondent asked Meek to have her former attorney prepare a Motion to Substitute so that Respondent could file it on or about July 22, 1991. A copy was faxed to Respondent on or about July 19, 1991, and then hand-delivered to Respondent on or about July 22, 1991. Respondent represented to Meek that he had filed the Motion to Substitute on July 22, 1991, when in fact Respondent had not. Respondent also represented to Meek that he had amended the petition when he had not.

Meek requested that Respondent sue the defendants individually, as well as the partnership, but Respondent failed to proceed at Meek's request. Respondent also failed to



Once a trial judge has been appointed, please forward the original and two (2) copies of the Disciplinary Petition, the Civil Case Information Sheet, and the filing fee check, also enclosed herewith, and the Court's appointing order to the District Clerk of Harris County, Texas, with the request that the suit be filed, service be obtained, and a filemarked copy of the petition be returned to the undersigned.

Also enclosed is a pre-addressed envelope for your use in transmitting the above referenced documents to the District Clerk of Harris County, Texas, and a return envelope to be sent to the District Clerk of Harris County, Texas, for the Clerk's use in returning a filemarked copy of the petition to the undersigned.
