
II.

MEMORANDUM

Attached is the list of attorneys whose MCLE compliance month DECEMBER and who remain in non-compliance with the MCLE requirements as of the date of this report.

We mailed each of these attorneys their Annual Verification Report during the first week of their birth month. Due to their non-compliance by the end of their birth month, we subsequently mailed to each of them a Non-Compliance Notice approximately the middle of the month following their birth month. The notice gave each of them 30 days to bring their record into compliance, and all of the attorneys included on the attached list failed to bring their record into compliance by the deadline. We then mailed a second non-compliance notice to both their office and home address (if available). Finally, we have also placed a telephone call to each attorney on the list for whom we could obtain a phone number, and we either spoke with the attorney directly or left word with their office that if the non-compliance was not cured then they would be subject to suspension. All names shown on the list still remain in non-compliance as of this date.

We have also prepared the Petition and Suspension Order that would need to be presented to the Court in order to effect these suspensions.

Please review this list and the Petition and Suspension Order for the Supreme Court. I would ask that you sign the petition as soon as possible, and then we will hand-carry this over to the Supreme Court.
