Order Declaring Joshua P. Knight a Vexatious Litigant

On May 17, 2021, the Court heard the Tarrant County District Clerk's motion to declare Joshua P. Knight a vexatious litigant. Based on the papers filed and the arguments of the parties, the Court finds that Joshua P. Knight meets the criteria to be declared a vexatious litigant under Texas Civil Practices and Remedies Code Chapter 11. Therefore, the Court **GRANTS** the motion and **ORDERS** as follows:

1. Joshua P. Knight is declared a vexatious litigant for all purposes.
2. Mr. Knight moved to dismiss his case and stated on the record that he did not wish to pursue his claims further. Accordingly, there is no need to stay this case or to require him to post security to maintain it.
3. Joshua P. Knight is prohibited from filing, pro se, any new litigation in any court in this State without the written permission of the appropriate local administrative judge in the jurisdiction where Knight attempts to file such litigation. The local administrative judge may condition permission upon Knight furnishing security for the benefit of the defendant(s) or any other condition as provided under Chapter 11 of the Texas Civil Practices and Remedies Code.
4. If Joshua P. Knight violates this pre-filing order, he will be subject to contempt of court in addition to the other remedies afforded under Chapter 11 of the Texas Civil Practices and Remedies Code.
