ORDER

BENT REMEMBERED that on this day came to be considered Defendants' Motion to Declare Plaintiff a Vexatious Litigant. After considering the pleadings of the parties filed herein and the argument of counsel, the Court is of the opinion that the Motion is meritorious and that the following Order should issue:

It is hereby ORDERED that said Motion is GRANTED. Plaintiff Modica is hereby DETERMINED TO BE A VEXATIOUS LITIGANT.

THEREFORE, Plaintiff is ORDERED to furnish security in the amount of Five Thousand Dollars (\$5,000). The amount must be furnished to the Court September 26, 2010. Should Plaintiff fail to furnish such security within the time set by this Order, the above-referenced and numbered cause is DISMISSED.

It is also FURTHER ORDERED that Amy Michele Modica is prohibited from filing, *in propria persona/pro se*, new litigation in a court in this state unless she has been granted, pursuant to a written order, permission to file such suit by a local administrative judge. The local administrative judge may grant Amy Michele Modica permission to file new litigation if they determine that such has merit and has not been filed for the purpose


of harassment or delay. The local administrative judge may condition permission to file new litigation on the furnishing of security for the benefit of the defendant as provided by subchapter B of Section 11.051, et seq, of the Texas Civil Practice and Remedies Code.

AMY MICHELE MODICA IS HEREBY PUT ON NOTICE THAT IF SHE FILES NEW LITIGATION IN THIS STATE IN VIOLATION OF THIS ORDER, SHE IS SUBJECT TO CONTEMPT OF COURT.

It is FURTHER ORDERED that a clerk of a court may not file litigation presented by Amy Michele Modica unless Amy Michele Modica obtains an order, described above, from the local administrative judge permitting the filing. If a clerk mistakenly files litigation without an order from the local administrative judge, any party may proceed in such litigation pursuant to Section 11.103(b) and (c) of the Texas Civil Practice and Remedies Code


It is also FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code.
