## ORDER DETERMINING PLAINTIFF, B. JOE THOMSON, AS A VEXATIOUS LITIGANT AND DETERMINING SECURITY REQUIRED BY PLAINTIFF

Came on for consideration the Motion of Robert F. Walker for Order Determining B. Joe Thomson, Plaintiff, as a Vexatious Litigant pursuant to Chapter 11 of the Civil Practices and Remedies Code, and after consideration of the pleadings in the cause, the verified motion, and taking judicial notice of the filings and dockets of various cases in which B. Joe Thomson has been a party, this Court finds sufficient grounds to support the motion and relief sought therein, and it is ordered that

- (A) B. Joe Thomson is a Vexatious Litigant under Chapter 11 of the Texas Civil Practices and Remedies Code; and
- (B) B. Joe Thomson shall furnish security in the amount of \$ 1000.00 in the form of cash to be deposited in the registry of this Court with the District Clerk of Harris County to secure the expenses and attorney's fees that Robert F. Walker may have upon conclusion of this case if he should prevail against B. Joe Thomson or this case should be dismissed for any reason; and
- (C) B. Joe Thomson shall post the security not later than Del. 8 if he should fail to post the security this cause of action shall be dismissed with prejudice as to Robert F. Walker, with all cost assessed against B. Joe Thomson; and
- (D) B. Joe Thomson is ordered to cease filing any new litigation in any court in Texas except pursuant to §11.102.
