ORDER - VEXATIOUS LITIGANT

BE IT REMEMBERED that on this day the Court on its own motion to declare Plaintiff as a Vexatious Litigant, the Court issues the following order:

The Court finds that Plaintiff LUIS S. LAGAITE, JR., TDCJ-CID #762508, is hereby DETERMINED TO BE A VEXATIOUS LITIGANT.

THEREFORE, Plaintiff is prohibited from filing any new litigation in this state *in forma pauperis*, and he is ordered to furnish security in the amount of \$500 as security concurrent with any future new litigation. Should Plaintiff fail to furnish such security along with new litigation, the Clerk shall decline to file such litigation and return same to the litigant unfiled at the litigant's last known address.

It is also FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code.




