

**ORDER**

On this the 21 day of July, 2009, came on to be heard the request of Judge Mary Bacon that the Court entered an Order directing the District Clerk to verify that R. Wayne Johnson has obtained permission from the Administrative Judge before the Clerk files any suits by this Plaintiff against Judge Mary Bacon. The Court notes that Plaintiff Johnson has abused both the state and federal judicial systems, and has specifically targeted Judge Bacon to be a victim of his harassment. For this reason, the Court finds that Judge Bacon's request is well taken and should be in all things granted.

**IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED** that the Harris County District Clerk is hereby instructed to comply with the Vexatious Litigant Statute. R. Wayne Johnson (TDCJ No. 282756) has previously been declared a vexatious litigant. Moreover, Mr. Johnson has been ordered to pay sanctions in the amount of \$300.00 to the Attorney General of Texas as a prerequisite to his ability to bring suits in the future. In view of the fact the Harris County District Clerk has allowed Mr. Johnson to circumvent the Vexatious Litigant Statute on three occasions, the Clerk is hereby ordered to direct all deputy clerks that they are not to accept for filing any lawsuit brought by R. Wayne Johnson against Defendant Mary Bacon without first verifying that the Presiding Judge has granted permission for Mr. Johnson to file said suit.
