**ORDER ON RESPONDENT'S MOTION FOR ATTORNEY'S FEES, EXPENSES, COSTS AND INTEREST; RESPONDENT'S PLEA IN BAR; RESPONDENT'S MOTION TO CONSIDER THIS PETITION AS A BILL OF REVIEW AND TO REQUIRE A SECURITY DEPOSIT OF \$25,000.00; MOTION TO DECLARE ROBERT A. LANSINK A VEXATIOUS LITIGANT AND REQUIRE SECURITY; AND MOTION FOR SANCTIONS**

On the 17<sup>th</sup> day of March, 2008, came to be heard Respondent's Original Answer.

IT IS ORDERED that Petitioner's Original Petition originally filed in the 48<sup>th</sup> Judicial District Court is barred and the case should have been filed as a Bill of Review under the original cause number. Additionally, it is found that Petitioner, ROBERT A. LANSINK failed to deposit \$25,000.00 into the Court's registry within three days of filing his Original Petition.

The Court finds that ROBERT A. LANSINK is a vexatious litigant.

IT IS ORDERED that Petitioner, ROBERT A. LANSINK is found to be a vexatious litigant and IT IS FURTHER ORDERED that

1. ROBERT A. LANSINK is prohibited from filing, in propria persona, a new litigation in a court in this State, unless ROBERT A. LANSINK, receives permission to file said suit under the requirements of section 11.102 of the Civil Practice and Remedies Code.
2. Any District Clerk of the State of Texas may not receive for filing a suit presented by ROBERT A. LANSINK, unless ROBERT A. LANSINK obtains an Order from a local administrative judge permitting the filing, pursuant to Section 11.102 of the Civil Practice and Remedies Code.

IT IS ORDERED that Petitioner, ROBERT A. LANSINK shall post a \$10,000.00 bond for any future filings in the Tarrant County District Courts.


