**PRE-FILING ORDER**

Came to be heard the Texas Department of Criminal Justice's Chapter 14 Motion to Dismiss and Chapter 11 Motion to Declare the Plaintiff a Vexatious Litigant and the Texas Department of Criminal Justice's Supplemental Chapter 14 Motion to Dismiss and Chapter 11 Motion to Declare the Plaintiff a Vexatious Litigant, and the Court having first declared Plaintiff Robert Troy McClure to be a vexatious litigant pursuant to the procedures set forth in TEX. CIV. PRAC. & REM. CODE Chapter 11, is of the opinion that the following order shall issue:

It is **ORDERED** that Robert Troy McClure is hereby prohibited from filing, *in propria persona*, any new litigation in a court of this State without first obtaining permission from a local administrative judge pursuant to TEX. CIV. PRAC. & REM. CODE § 11.102. If Plaintiff Robert Troy McClure does file new litigation in violation of this order, that suit will be subject to dismissal and Plaintiff Robert Troy McClure will be subject to sanctions as proscribed by TEX. CIV. PRAC. & REM. CODE § 11.101(b).
