

Respondent then suggested to Complainant that she be served by publication, to which Complainant agreed and preferred. Respondent did not serve Complainant's wife in the manner that Complainant requested, preferred, and/or understood that Respondent would do. Instead, Respondent located Complainant's wife through her father and she signed a Waiver of Citation and Appearance on August 15, 1998. Because of Respondent's conscious disregard of his responsibilities to Complainant, the waiver expired and Complainant was not able to use the waiver to establish service upon his wife.


