The Supreme Court appointed a Gender Bias Task Force in 1991 to investigate the existence of gender bias in the legal system and recommend measures for its reduction and eventual elimination (Misc. Docket No. 91-19);

The Gender Bias Task Force's 1994 final report was received;

In October 1994 the Supreme Court of Texas appointed the Gender Bias Implementation Committee to implement the recommendations of the Task Force (Misc. Docket No. 94-9175);

The Committee was charged with planning, overseeing and monitoring implementation of the recommendations of the original Gender Bias Task Force, as well as monitoring and implementing other policies and procedures to eliminate gender bias in the Texas legal system;

Today's order reflects the changes in the membership of the Gender Bias Reform Implementation Committee;


