ORDER OF THE SUPREME COURT OF TEXAS 9073 MISC. DOCKET NO. 06-

IN THE MATTER OF JAY E. RIGGINS

The Court has reviewed the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Jay E. Riggins and the Response of the Chief Disciplinary Counsel for the Commission for Lawyer Discipline. The Court concludes each meets the requirements of Part X of the Texas Rules of Disciplinary Procedure. In the absence of a request by Jay E. Riggins to withdraw his motion, the Court deems the professional misconduct detailed in the Response of Chief Disciplinary Counsel conclusively established for all purposes. The Court further concludes that acceptance of Jay E. Riggins' resignation is in the best interest of the public and the profession.

Therefore, the law license of Jay E. Riggins of Corpus Christi, Texas, State Bar Card Number 00794529, is canceled. The Court finds that Jay E. Riggins has surrendered his State Bar Card to the Clerk of the Supreme Court of Texas, but represented to the Court that he had lost his Texas law license and therefore shall file with the court an affidavit stating that he is unable to locate his Texas law license and will surrender it to the court should he find it.

Consequently, Jay E. Riggins is prohibited from practicing law in the State of Texas. This includes holding himself out as an attorney at law, performing legal services for others, giving legal advice to others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative body (whether state, county, municipal, or other), or holding himself out to others or using his name in any manner in conjunction with the words "Attorney at Law," "Counselor at Law," "Lawyer," or "Attorney."

Additionally, Jay E. Riggins must immediately notify in writing each of his current clients of

his resignation. He shall also return any files, papers, unearned monies and other property in his possession belonging to any client or former client to the respective client or former client or to another attorney at the client's or former client's request. Jay E. Riggins shall file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, 126 East Nueva Street, Suite 200, San Antonio, Texas 78204, within thirty (30) days of the date of this Order an affidavit stating that all current clients have been notified of his resignation and that all files, papers, monies, and other property belonging to all clients and former clients have been returned.

Finally, Jay E. Riggins shall, within thirty (30) days after the date of this Order, notify in writing each justice of the peace, judge, magistrate, and chief justice of each court in which Jay E. Riggins has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s) Jay E. Riggins is representing in court. Jay E. Riggins shall file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, Post Office Box 12487, Austin, Texas 78711-2487, within thirty (30) days of the date of this Order an affidavit stating that he has notified in writing each justice of the peace, judge, magistrate, and chief justice of each court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the name, address and telephone number of the has any matter pending of the terms of this Order an affidavit stating that he has notified in writing each justice of the peace, judge, magistrate, and chief justice of each court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s)he is representing in Court.
