## ORDER OF THE SUPREME COURT OF TEXAS MISC. DOCKET NO. 06- 9151 IN THE MATTER OF FANCHARM H. GIBSON

On this day, the Court considered the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Fancharm H. Gibson, together with the Response of the Chief Disciplinary Counsel to the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Fancharm H. Gibson. The Court has reviewed said Motion and Response and finds that each meets the requirements of Part X of the Texas Rules of Disciplinary Procedure. In conformity with Part X, Section 10.02 of the Texas Rules of Disciplinary Procedure, the Court considers the detailed statement of professional misconduct contained within the Response of Chief Disciplinary Counsel to be deemed conclusively established for all purposes. The Court finds that Fancharm H. Gibson is resigning in lieu of discipline. The Court, being advised that the acceptance of the resignation is in the best interest of the public and the profession, hereby concludes that the following Order is appropriate.

**IT IS ORDERED** that the law license of Fancharm H. Gibson of Dallas, Texas, State Bar card number 07861800, which was previously issued by this Court, be canceled and her name be dropped and deleted from the list of persons licensed to practice law in Texas.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson immediately surrender her State Bar Card and Texas law license to the Clerk of the Supreme Court of Texas or file with the Court an affidavit stating the cause of her inability to do so.

IT IS FURTHER ORDERED that Fancharm H. Gibson is permanently enjoined and prohibited from practicing law in the State of Texas, holding herself out as an attorney at law,

performing legal services for others, giving legal advice to others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative body (whether state, county, municipal, or other), or holding herself out to others or using her name in any manner in conjunction with the words "Attorney at Law," "Counselor at Law," or "Lawyer."

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, on or before ninety (90) days from the effective date of this Order, make restitution in the amount of Five Hundred Fifty-Four and 20/100 Dollars (\$554.20) to Wanda Jean Dawson. Said restitution shall be made by cashier's check or money order made payable to Wanda Jean Dawson, and delivered to the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, on or before ninety (90) days from the effective date of this Order, make restitution in the amount of Two Thousand Seven Hundred Fifty-Seven and 56/100 Dollars (\$2,757.56) to Anabel Roman. Said restitution shall be made by cashier's check or money order made payable to Anabel Roman, and delivered to the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, on or before ninety (90) days from the effective date of this Order, make restitution in the amount of Eight Thousand Six Hundred Sixty-Seven and 10/100 Dollars (\$8,667.10) to Adnan Alharbi. Said restitution shall be made by cashier's check or money order made payable to Adnan Alharbi, and delivered to the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, on or before ninety (90) days from the effective date of this Order, make restitution in the amount of Five Thousand and no/100 Dollars (\$5,000.00) to Dr. Michael Davis. Said restitution shall be made by cashier's check or money order made payable to Dr. Michael Davis, and delivered to the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, on or before ninety (90) days from the effective date of this Order, make restitution in the amount of One Thousand Five Hundred Sixty-Six and 66/100 Dollars (\$1,566.66) to Kimberly Montgomery. Said restitution shall be made by cashier's check or money order made payable to Kimberly Montgomery, and delivered to the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall immediately notify each of her current clients in writing of this resignation. In addition to such notification, Fancharm H. Gibson is **ORDERED** to return any files, papers, uncarned monies and other property belonging to clients in her possession to the respective clients or to another attorney at the client's request. Fancharm H. Gibson is **ORDERED** to file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752, within thirty (30) days of the effective date of this Order an affidavit stating that all current clients have been notified of her resignation and that all files, papers, monies and other property belonging to all clients have been returned as ordered herein.

**IT IS FURTHER ORDERED** that Fancharm H. Gibson shall, within thirty (30) days after the date on which this Order is signed by the Court, notify in writing each and every justice of the

peace, judge, magistrate, and chief justice of each and every court in which Fancharm H. Gibson has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name(s), address(es) and telephone number(s) of the client(s) Fancharm H. Gibson is **ORDERED** to file with the State Bar of Texas at Office of the Chief Disciplinary Counsel, attn: Nancy Ashcraft, 6300 La Calma Drive, Suite 300, Austin, Texas 78752, within thirty (30) days of the effective date of this Order an affidavit stating that she has notified in writing each and every justice of the peace, judge, magistrate, and chief justice of each and every court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name(s), address(es) and telephone number(s) of the client(s) she is representing in Court.
