REPORT OF JUDGES IN NONCOMPLIANCE WITH RULES OF JUDICIAL EDUCATION


ORDERED:

Judges Not in Compliance with Rules of Judicial Education
May 26, 1993

1. **Cable, Chad - Judge, County Court at Law**
Has accrued 26.75 hours of the required 30.0 hours for a new judge for 1992.
He has not responded to letters notifying him of non-compliance.
2. **O'Connell, Burt - Matagorda County Judge**
Has accrued 0.0 hours in 1992 of the required 16.0 hours. Per telephone conversation has stated that he retired as Judge on 12/31/92.
Reported as no longer in office.
3. **Stavely, Charles H. Jr. - Terrell County Judge**
Has carried forward 3.0 hours from 1991 and accrued 0.0 hours in 1992 of the required 16.0 hours. Per phone conversation on 3/8/93 Judge Stavely has said he is no longer a judge and will send a letter to that effect.
Reported as no longer in office.
4. **Hampton, John - City of Oak Point Municipal Judge**
Requested waiver due to the fact he is a part-time judge.
5. **Shaper, Robert T. - City of Pattison Municipal Judge**
Requested waiver because the city does not hold court and has no funds.
6. **Stovall, Ron - City of Roscoe Municipal Judge**
Requested waiver due to conflict in schedule.
7. **Leggett, Kenneth T. - City of Abilene Municipal Judge**
Resigned position as judge.
8. **Overstreet, Cecil - Justice of the Peace, Hardin County, Pct. 3, Pl. 1**
Personal Medical reasons.
An unconditional waiver had been previously granted for Sept. 1, 1990 - Aug. 31, 1991.
9. **Garcia, Trinidad - Justice of the Peace, La Salle County, Pct. 2, Pl. 1**
Personal Medical Reasons.
Received a letter from Judge Garcia dated 3/8/93 stating that due to his illness he will not seek another term a Justice of the Peace.
Previously, the Judicial Education Executive Committee referred the name of this judge to the Supreme Court with a recommendation that he be reported to the Commission on Judicial Conduct for failure to comply with the Rules of Judicial Education for Sept. 1, 1989 - Aug. 31, 1991.
10. **Thomas, Harold**
Senior District Judge (Retired)
Has accrued 0.0 of the required 16.0 hours for 1992.
Health Reasons.
