**ORDER OF APPROVAL  
OF TECHNICAL CORRECTIONS  
TO THE DISCIPLINARY RULES**


WHEREAS, this Court's previous Miscellaneous Docket Order No. 94-9167, dated November 15, 1994, contained nonsubstantive, technical errors in the rules and amendments it promulgated, the Court hereby approves the following technical corrections.


1. RULE 7.03. Change the title of this rule to make the word "solicitation" plural.
2. RULE 7.03(b). Add a comma after the phrase, "or referring clients or prospective clients to."
3. RULE 7.03(b). Add a comma after the word "firm" in the phrase "lawyer or firm except that."
4. RULE 7.04(b)(3). Change as follows: Replace the period following "Texas Board of Legal Specialization" with a comma, and change the first letter of the next word, "however," to lower case.
5. RULE 7.05(a). Make the initial letters in each subpart lower case.
6. RULE 7.05(b)(2). Relabel the subpoints in this subsection with lower case roman numerals, removing the lower case alphabetic designations used in the original order.
7. RULE 7.05(b)(2). Make this subpart a single sentence by: (1) replacing the period after the second use of the word "ADVERTISEMENT" with a comma (placed inside the quotation mark); (2) inserting the word "however" followed by a comma following the quotation mark; and (3) changing the first letter of the word "if" to lower case.


8. RULE 7.07(b). Replace the phrase, "a copy of each lawyer's advertisements in the public media" with the phrase "a copy of that advertisement."
9. RULE 7.07(d)(1)(i). Place the semicolon at the end of this subpart outside of the quotation mark.
10. RULE 7.07(d)(1)(iii). Replace the phrase "admission by the lawyer" with "admission of the lawyer."
11. RULE 7.07(d)(2)(ii). Insert the word "the" in the phrase "name of lawyers or firm," so that the phrase reads, "name of the lawyers or firm."

These changes shall become effective immediately.




