It is therefore ORDERED that those attorneys licensed to practice law in the State of Texas listed in Exhibit (1) hereto are forthwith Suspended as attorneys in the State of Texas, and shall not practice law unless and until they have complied with the requirements of the Minimum Continuing Legal Education program and paid to the State Bar of Texas all fees and charges owed for their failure to comply timely,


II.
