- Provides information on court statistics, judicial system structure and jurisdiction, and other information to the public;
- Produces, in conjunction with Public Affairs, the *Annual Statistical Report for the Texas Judiciary*; and
- Produces the *Texas Judicial System Directory*.

The majority of Judicial Information staff's time is devoted to assisting clerks and courts with their monthly reports (commonly called "OCA Reports") as well as other reporting requirements, if relevant.
