PREFILING ORDER DETERMINING PLAINTIFF SUSAN ANN FISHER TO BE A VEXATIOUS LITIGANT AND REQUIRING SECURITY

Before the Court are Defendants Alireza Zafarmand Atef, MD and Salman Waheed, MD's Motion for Order Determining Plaintiff Susan Ann Fisher to be a Vexatious Litigant and Requesting Security and Seeking Injunction and Defendants Medical Center of Plano, Ray J. Delgadillo, RT, Anne W. Handley, RN, and Cynthia Carter, RN's Motion for Order Determining Plaintiff Susan Ann Fisher to be a Vexatious Litigant and Requesting Security and Seeking Injunction ("Motions"). Having considered the Motions and exhibits thereto, the Responses filed by Plaintiff Susan Ann Fisher and exhibits thereto, all briefing and exhibits including supplemental and amended briefing and exhibits, the pleadings on file in this case, the pleadings on file in other Collin County cases filed by Susan Ann Fisher against these same Defendants considered by judicial notice and by exhibit, the arguments of counsel and the pro se litigant, and the evidence presented at the evidentiary hearing, this Court is of the opinion that the Motions are well taken and should be GRANTED.

The Court FINDS that there is not a reasonable probability Plaintiff Susan Ann Fisher will

prevail in this litigation against the Defendants due to the doctrine of res judicata because the claims

in this litigation were fully litigated and decided in Susan Ann Fisher v. Medical Center of Plano,

Alireza Zafarman Atef, MD, Salman Waheed, MD, Ray J. Delgadillo, RT, Anne W. Handley, RN,

Cynthia Carter, RN & Michael Allen, RT, in this 296th Judicial District Court of Collin County,

Texas, Cause No. 296-01024-2014.

The Court further FINDS that Plaintiff Susan Ann Fisher, after her litigation has been finally

determined against her, has repeatedly relitigated or attempted to relitigate, pro se, the validity of the

final determination or the same cause of action, claim, controversy, or issues of fact or law already

determined or concluded by a final determination against the same Defendants.

It is therefore ORDERED that Plaintiff Susan Ann Fisher is determined a VEXATIOUS

LITIGANT pursuant to Section 11.054(2) of the Texas Civil Practice and Remedies Code.

The Court hereby enters this PREFILING ORDER as provided in Sections 11.101, 11.102,

and 11.103 of the Texas Civil Practice and Remedies Code and ORDERS that Plaintiff Susan Ann

Fisher is enjoined from filing further lawsuits in propria persona in Collin County in the absence of

permission from the local administrative judge.

It is further ORDERED that Plaintiff Susan Ann Fisher must furnish security pursuant to

Section 11.055 of the Texas Civil Practice and Remedies Code in the amount of \$50,000.00 by the

to assure payment of Defendants' reasonable expenses incurred in

or in connection with a litigation commenced, caused to be commenced, maintained, or caused to be

maintained by Plaintiff Susan Ann Fisher, including reasonable costs and attorney's fees.

It is further ORDERED that Plaintiff Susan Ann Fisher must furnish the ordered security

prior to filing any further pleadings, motions, or documents in any court in Collin County, Texas.
