On the 7th day of August 2009 came on to be considered the Defendants' Motion to Declare Plaintiff a Vexatious Litigant, filed herein by Defendants, MARTIN & DROUGHT, P.C. F/K/A MARTIN & DROUGHT, INC. AND F/K/A MARTIN, DROUGHT & TORRES, INC.; GERALD T. DROUGHT; and DAIN A. DREYER. Defendants appeared by and through their counsel of record, and Plaintiff appeared pro se. The Court, having considered the evidence presented and the arguments of the parties, finds the following Order appropriate. It is, therefore,

ORDERED that Plaintiff, KRISTOFER THOMAS KASTNER, should be and hereby is declared a vexatious litigant. It is further

ORDERED that Plaintiff shall furnish security for Defendants' costs and attorney's fees, either by cash deposit with the Bexar County District Clerk, or by surety bond to be approved by the Court, in the amount of \$\frac{17.500}{17.500}\], on or before \$\frac{17.500}{100}\], it is further

ORDERED that this case, including all discovery, is stayed until Plaintiff posts the security ordered herein, and that in the event that Plaintiff fails to timely post the security ordered herein, this case shall be dismissed with prejudice against refiling. It is further



ORDERED that Plaintiff is prohibited from filing any further litigation against Defendants MARTIN & DROUGHT, P.C. F/K/A MARTIN & DROUGHT INC. AND F/K/A MARTIN, DROUGHT & TORRES, INC.; GERALD DROUGHT; and/or DAIN A. DREYER in any court in this state unless Plaintiff secures, prior to filing, permission of the local administrative judge of the court which Plaintiff intends to file such litigation. It is further

ORDERED that the Bexar County District Clerk shall provide a copy of this Order to the Office of Court Administration of the Texas Judicial System.
