

Background

<u>Article 102.017(f)</u>, Code of Criminal Procedure, requires a local administrative judge to submit a written report to the Office of Court Administration (OCA) regarding any incident involving court security that occurs in or around a building housing a court. A security incident is defined as any adverse event that threatens the security of a person or property, or causes or may cause significant disruption to functions of the court due to a breach in security.


The purpose of the Security Incident Report is to collect concrete, quantitative information about the frequency and nature of the security threats facing the judiciary.

Number of Incidents Reported










"Other" areas included a case manager office, entrance of courthouse, court lobby, security checkpoint, and a secure area near judge.





"Other" perpetrators included an attorney, an attorney's assistant, jury panel member, and a magistrate judge.


Incidents by Behavior Reported

n=113



Weapons




Most of the weapons classified as "Other" were knuckles.




Weapons Used in Security Incidents n=3


Weapons classified as "Other" were a box cutter blade and scissors.

Incidents Involving Injury






Charges Filed




Case Type Associated with Incidents in Which Charges were Filed or Pending
