### Job Description:

The Court of Appeals, Third District of Texas, is accepting applications for the position of a staff attorney for Justice Cindy Olson Bourland. In addition, a court attorney may be called upon to review and screen original proceedings and motions, prepare pre-submission memoranda in selected cases, review appellate records submitted for filing, conduct legal research to assist the Court in the disposition of appellate issues, review current developments in the law, and assist the Clerk in his administrative duties.

### Job Requirement:

- Applicants must be currently licensed to practice law in Texas; preferably have at least five years of practical experience; and have a strong background in trial and appellate procedure, legal research, and writing. Prior experience as an appellate staff attorney is strongly preferred. Experience in administrative law and administrative procedure is also strongly preferred. Applicants must be able to work at a fast pace and be extremely thorough in their writing and proofreading skills.
- Graduation from an accredited law school with a Bachelor of Laws or a Juris Doctor degree.
