

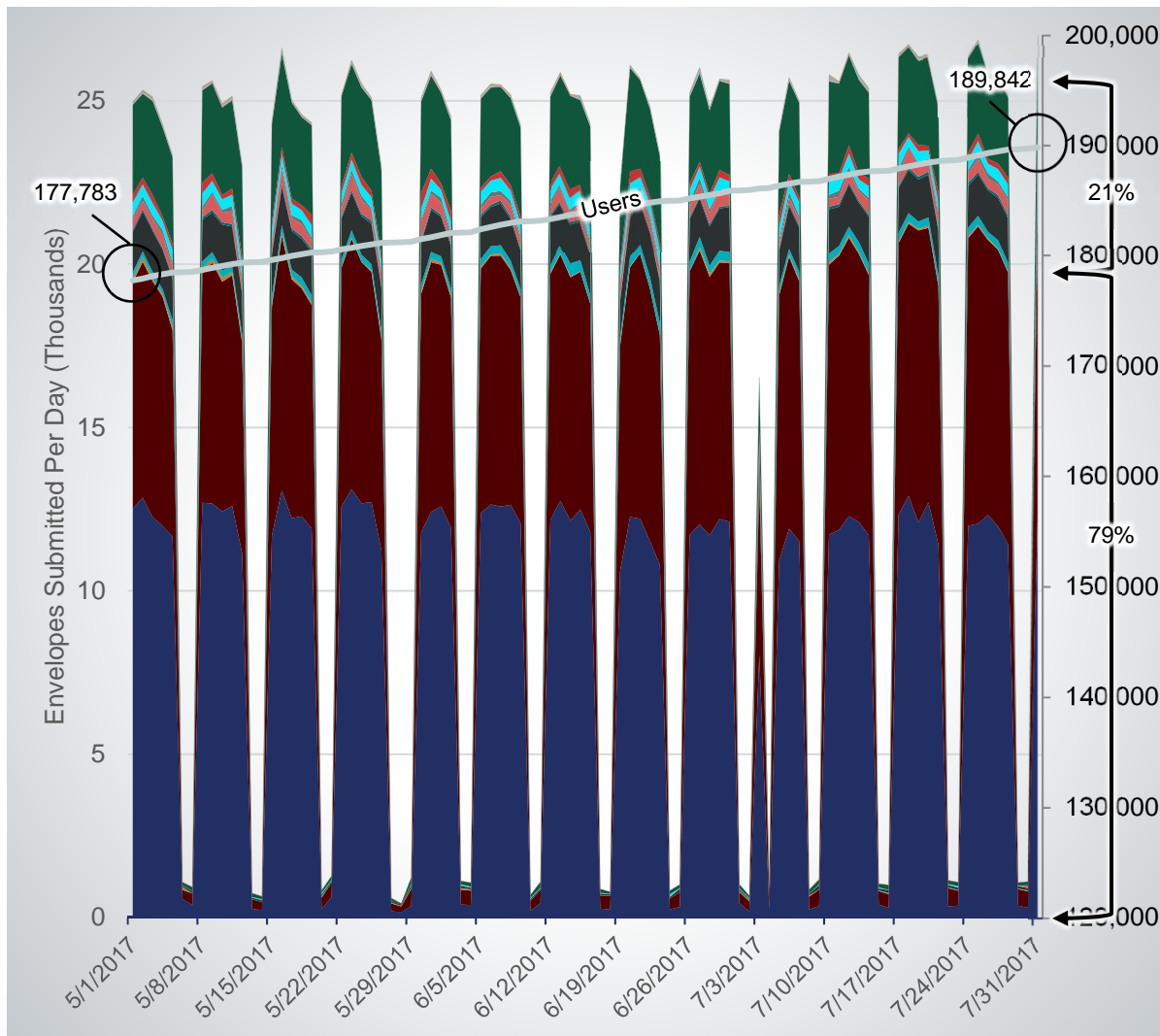

Summary

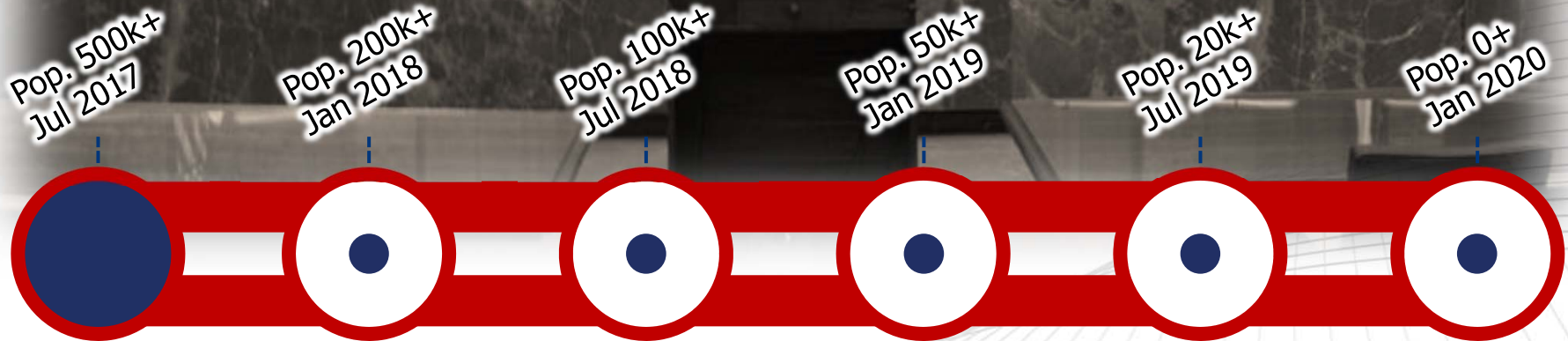
- Over 189k user accounts created to-date
- EFM currently receiving ~25,800 envelopes per day
- State filing portal accounts for 79% of transactions; remaining 21% stem from commercial EFSP submissions

Criminal Mandate

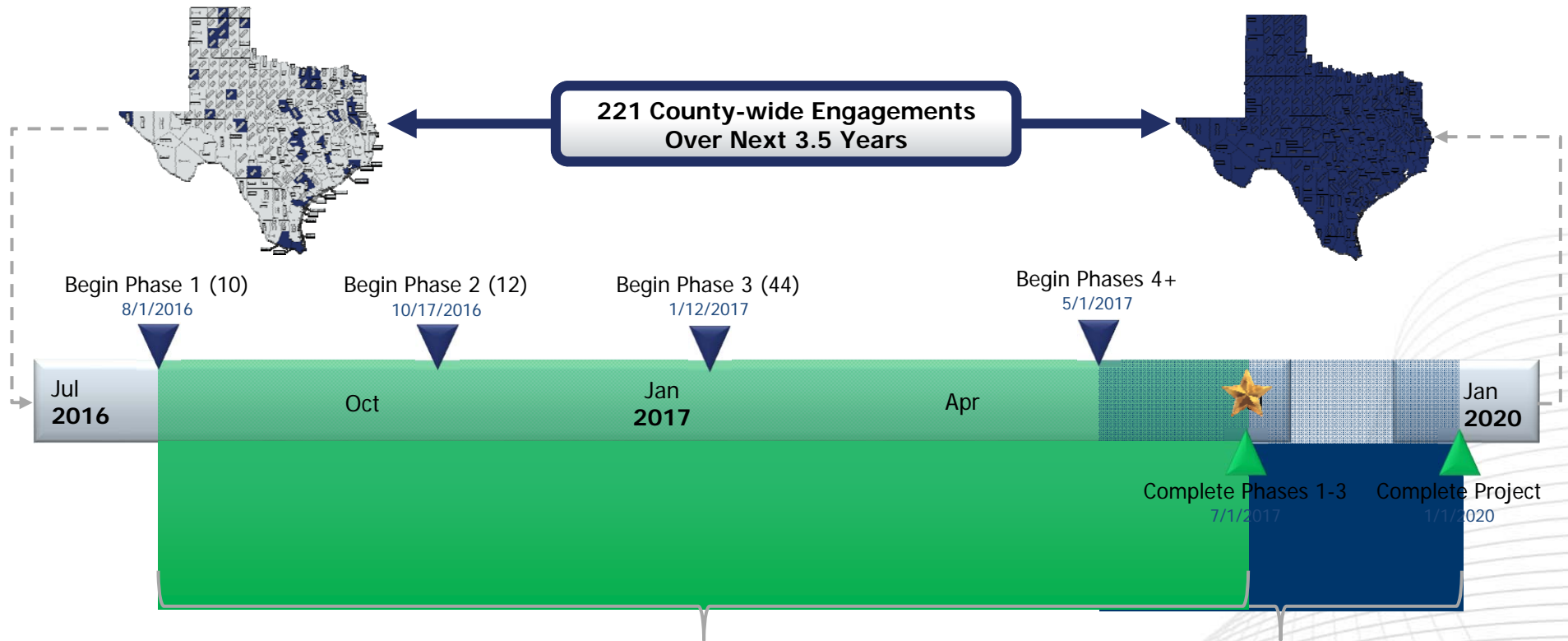


The Court of Criminal Appeals chose to mandate e-filing in criminal matters in June 2016

- Impacts all 254 counties
- Graduated scheduled roll-out, based on county population

Phases 1-3 Summary ✓

- Phases 1-3 consists of 66 counties
 - *63 counties live in these phases
- 105 counties currently live across all phases

*Tarrant, Travis and Harris were granted extensions.

Future Phase Summary

- 149 counties in plan for future phases
- Will expedite implementation engagements when possible

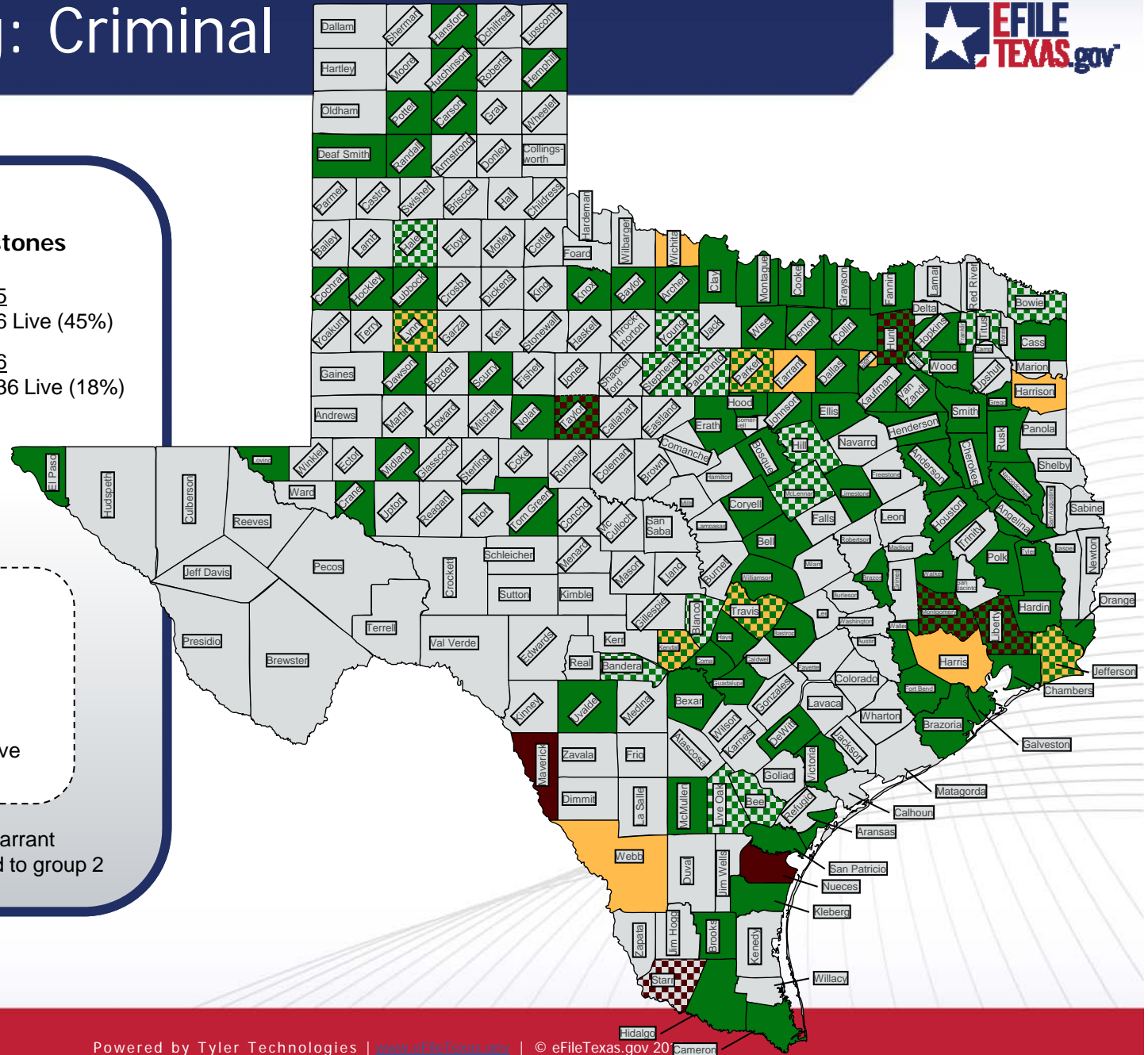

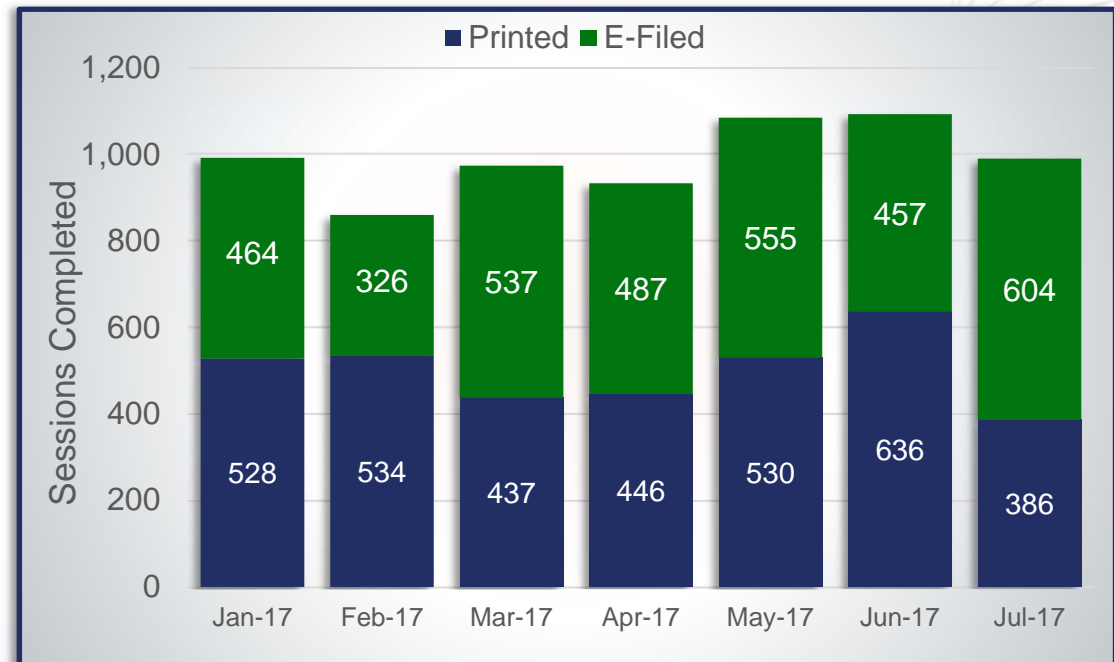

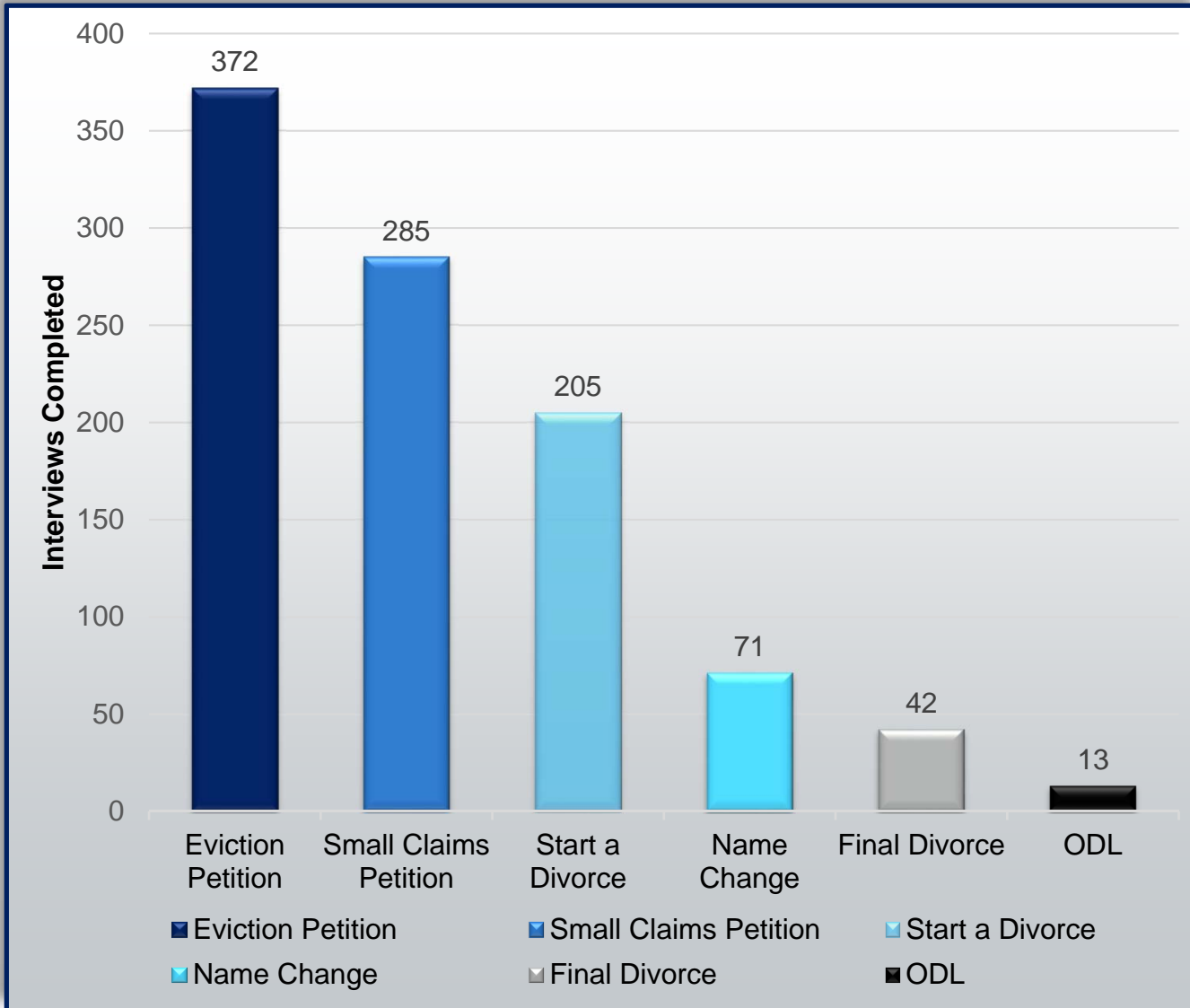

July 2017



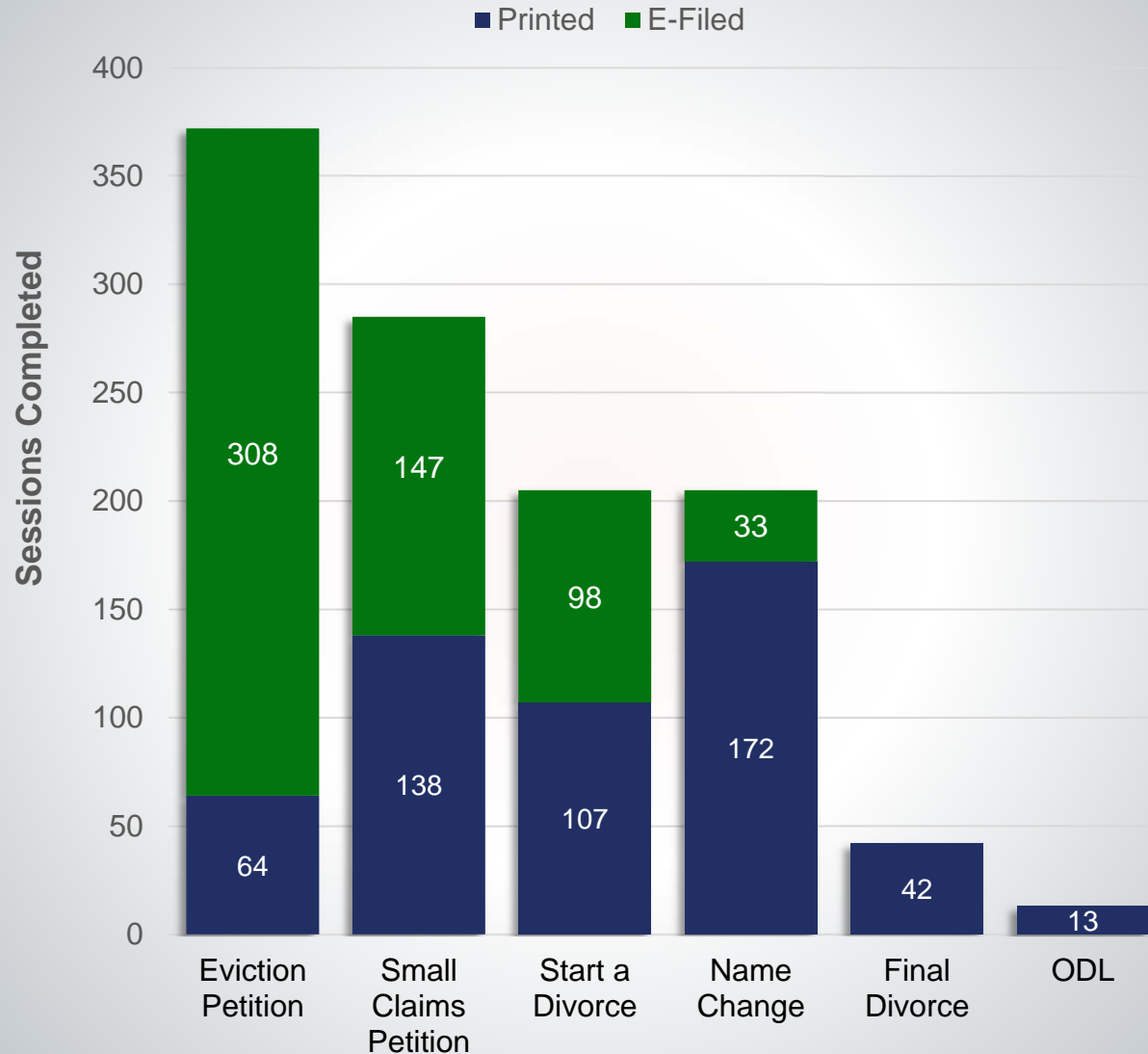
Summary

- 35% year over year increase in Self-Help registered users



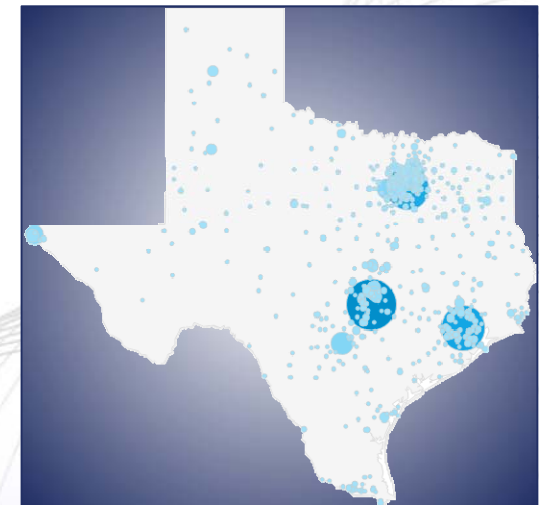
Interview Submission Types
