16-0098 THE DALLAS MORNING NEWS, INC. AND STEVE BLOW v. JOHN TATUM AND MARY ANN TATUM; from Dallas County; 5th Court of Appeals District (05-14-01017-CV, 493 SW3d 646, 12-30-15)

respondents' motion for sanctions denied

The Court reverses the court of appeals' judgment and renders judgment.

Justice Brown delivered the unanimous opinion of the Court with respect to Parts I, II, III.B, and IV, the opinion of the Court with respect to Part III.A, in which Chief Justice Hecht, Justice Green, Justice Guzman, and Justice Devine joined, and an opinion with respect to Part III.C, in which Chief Justice Hecht and Justice Johnson joined.

Justice Boyd delivered a concurring opinion, in which Justice Lehrmann and Justice Blacklock joined.

17-0062 JODY JAMES FARMS, JV v. THE ALTMAN GROUP, INC. AND LAURIE DIAZ; from Floyd County; 7th Court of Appeals District (07-15-00060-CV, 506 SW3d 595, 10-17-16)

The Court reverses the court of appeals' judgment, vacates the arbitration award, and remands the case to the trial court.

Justice Guzman delivered the opinion of the Court.
