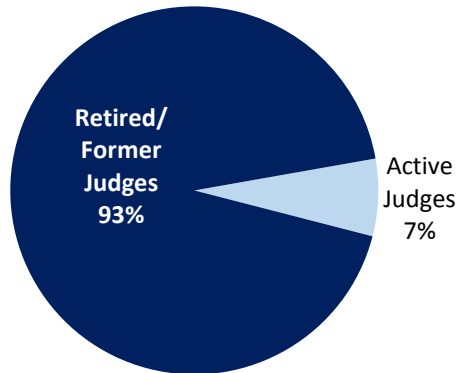

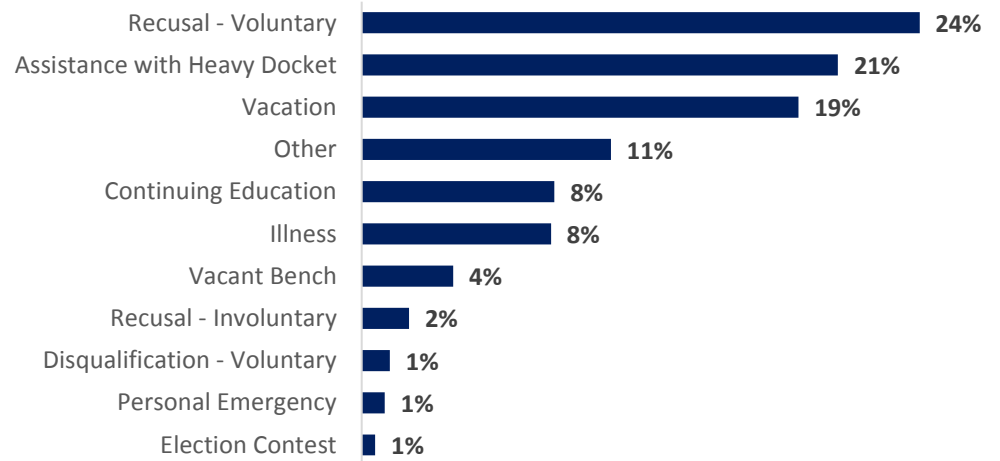

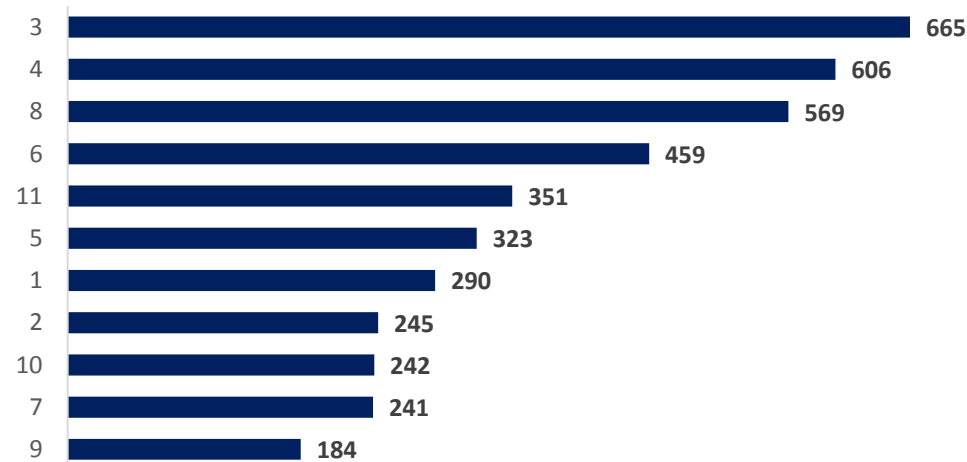
Percentage of Assignments by Judge Type



Reason for Assignment

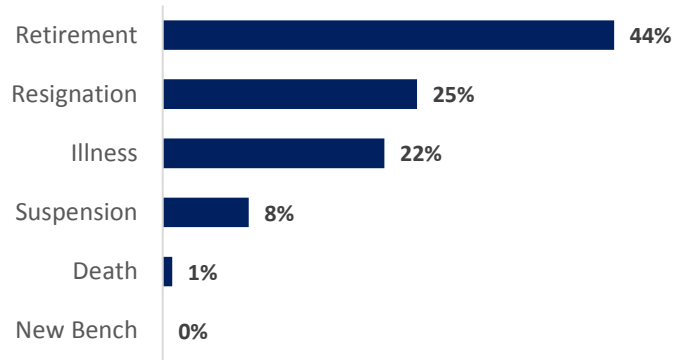


Number of Assignments by Region



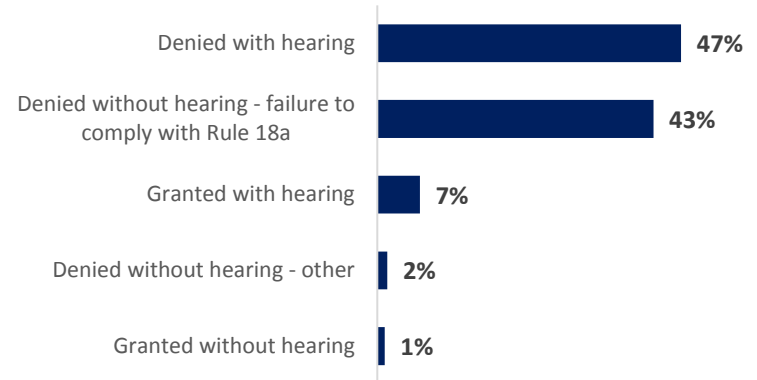

Percentage of Total Days Spent Serving on Vacant Bench Due to

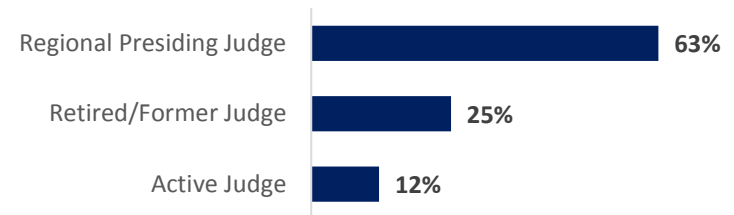
