The meeting of the Judicial Branch Certification Commission (JBCC or Commission) was called to order by Judge Lee Hamilton, Chair, at 10:00 a.m., Friday, November 1, 2019. Over the last 19 years, Ms. Henricks served as the Director of the Court Reporters Certification Board and JBCC Compliance Manager. Sheryl Jones, who served as Licensing Specialist for court reporters for 19 years, was promoted to Licensing Manager.
