## ORDERS ON CAUSES

18-0841 TOMMY YOWELL, ET AL. v. GRANITE OPERATING COMPANY AND APACHE CORPORATION, ET AL.; from Wheeler County; 7th Court of Appeals District (07-17-00112-CV, 577 SW3d 794, 07-26-18)

The Court affirms in part and reverses in part the court of appeals' judgment and remands the case to that court.

Justice Busby delivered the opinion of the Court.

18-0932 EX PARTE E.H.; from Fort Worth County; 2nd Court of Appeals District (02-17-00419-CV, 582 SW3d 445, 08-16-18)

The Court reverses the court of appeals' judgment and reinstates the trial court's judgment.

Justice Boyd delivered the opinion of the Court, in which Chief Justice Hecht, Justice Green, Justice Guzman, Justice Lehrmann, Justice Devine, Justice Busby, and Justice Bland joined.

Justice Blacklock delivered a dissenting opinion.

18-1041 IN RE COLTON LESTER; from Polk County

The Court conditionally grants the writ of mandamus.

Justice Devine delivered the opinion of the Court, in which Chief Justice Hecht, Justice Green, Justice Guzman, Justice Lehrmann, Justice Busby, and Justice Bland joined.

Justice Boyd delivered a dissenting opinion.

Justice Blacklock delivered a dissenting opinion, in which Justice Boyd joined as to Part I.

18-1053 IN RE COMMITMENT OF MAURICE BLUITT; from Fort Worth County; 2nd Court of Appeals District (02-17-00150-CV, 562 SW3d 665, 09-27-18)

The Court affirms the court of appeals' judgment.

Justice Devine delivered the opinion of the Court.

19-0590 IN THE INTEREST OF Z.N., A CHILD; from Potter County; 7th Court of Appeals District (07-18-00440-CV, 579 SW3d 140, 06-06-19)

Pursuant to Texas Rule of Appellate Procedure 59.1, without hearing oral argument, the Court reverses the court of appeals' judgment and remands the case to that court.
