#### **ORDERS ON CAUSES**

21-0307 CITY OF LEAGUE CITY, TEXAS v. JIMMY CHANGAS, INC.; from Galveston County; 14th Court of Appeals District (14-19-00776-CV, 619 SW3d 819, 02-18-21)

The Court affirms the court of appeals' judgment and remands the case to the trial court.

Justice Boyd delivered the opinion of the Court, in which Chief Justice Hecht, Justice Lehrmann, Justice Devine, Justice Busby, Justice Huddle, and Justice Young joined.

Justice Young filed a concurring opinion.

Justice Blacklock filed a dissenting opinion, in which Justice Bland joined as to Part III.

The Court affirms the court of appeals' judgment.
